Good Afternoon,

I am contacting you in respect of the above application and to seek your agreement to an additional condition being added to the Premises Licence if granted.

The application states 'Supply of alcohol consumption on the premises with food will take place during permitted hours'. As such I would request the following be added to the licence:

1. The premises must operate as a restaurant:
  - i. In which customers must be seated at a table;
  - ii. Which provides substantial table meals that are prepared on the premises and are served and consumed at the table;
  - iii. Where alcohol must not be sold, supplied, or consumed on the premises otherwise than to persons who are taking substantial table meals and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.
2. Service of alcohol shall be by waiter/waitress only.

I hope this is agreeable, and look forward to hearing from you accordingly.
