## **6. DRAFT EPPING FOREST DISTRICT LOCAL PLAN FOR CONSULTATION**

### **Decision:**

(1) That the Draft Local Plan (Appendix 1 of the report) and the non technical summary of the Sustainability Appraisal (Appendix 2 of the report) be endorsed and that consultation on the Draft Local Plan under Regulation 18 of the Town and Country Planning (Local Planning) Regulations 2012 should commence for a 6 week statutory period from 31 October to 12 December 2016 in accordance with the Statement of Community Involvement, and that representations received after 5.00pm on 12 December 2016 would be deemed invalid, be recommended to the Council for approval;

(2) That the endorsement of the Draft Local Plan as a material consideration to be used in the determination of planning applications and enforcement decisions, in accordance with paragraph 216 of the National Planning Policy Framework, be recommended to the Council for approval; and

(3) That the granting of delegated authority to the Director of Neighbourhoods, in consultation with the Planning Policy Portfolio Holder, to make any necessary minor non-material amendments to the Draft Local Plan prior to the commencement of public consultation on 31 October 2016 be recommended to the Council for approval.
