- 2 The development hereby permitted will be completed strictly in accordance with the approved drawings nos: FP15584/100, FP15584/01, FP15584/02A
- 3 No development shall have taken place until samples of the types and colours of the external finishes have been submitted to and approved by the Local Planning Authority in writing prior to the commencement of the development. - 7 Should the Phase 1 Land Contamination preliminary risk assessment carried out under the above condition identify the presence of potentially unacceptable risks, no development shall take place until a Phase 2 site investigation has been carried out. A protocol for the investigation shall be submitted to and approved by the Local Planning Authority before commencement of the Phase 2 investigation. The completed Phase 2 investigation report, together with any necessary outline remediation options, shall be submitted to and approved by the Local Planning Authority prior to any redevelopment or remediation works being carried out. The report shall assess potential risks to present and proposed humans, property including buildings, crops, livestock, pets, woodland and service lines and pipes, adjoining land, groundwaters and surface waters, ecological systems, archaeological sites and ancient monuments and the investigation must be conducted in accordance with DEFRA and the Environment Agency's "Model Procedures for the Management of Land Contamination, CLR 11", or any subsequent version or additional regulatory guidance.

- 8 Should Land Contamination Remediation Works be identified as necessary under the above condition, no development shall take place until a detailed remediation scheme to bring the site to a condition suitable for the intended use has been submitted to and approved by the Local Planning Authority. The development shall be carried out in accordance with the approved remediation scheme unless otherwise agreed in writing by the Local Planning Authority. The remediation scheme must include all works to be undertaken, proposed remediation objectives and remediation criteria, timetable of works and site management procedures and any necessary long term maintenance and monitoring programme. The scheme must ensure that the site will not qualify as contaminated land under Part 2A of the Environmental Protection Act 1990 or any subsequent version, in relation to the intended use of the land after remediation.

- 9 Following completion of measures identified in the approved remediation scheme and prior to the first use or occupation of the development, a verification report that demonstrates the effectiveness of the remediation carried out must be produced together with any necessary monitoring and maintenance programme and copies of any waste transfer notes relating to exported and imported soils shall be submitted to the Local Planning Authority for approval. The approved monitoring and maintenance programme shall be implemented.
- 10 In the event that any evidence of potential contamination is found at any time when carrying out the approved development that was not previously identified in the approved Phase 2 report, it must be reported in writing immediately to the Local Planning Authority. An investigation and risk assessment must be undertaken in

accordance with a methodology previously approved by the Local Planning Authority. Following completion of measures identified in the approved remediation scheme, a verification report must be prepared, which is subject to the approval in writing of the Local Planning Authority in accordance with the immediately above condition.

- 11 All construction/demolition works and ancillary operations, including vehicle movement on site which are audible at the boundary of noise sensitive premises, shall only take place between the hours of 07.30 to 18.30 Monday to Friday and 08.00 to 13.00 hours on Saturday, and at no time during Sundays and Public/Bank Holidays unless otherwise agreed in writing by the Local Planning Authority.

**REASONS FOR REFUSAL**

- 1 The proposal constitutes inappropriate development in the Metropolitan Green Belt which erodes openness and by definition causes harm to the Green Belt. Planning permission should not be granted for inappropriate development in the Green Belt, save in very special circumstances. The applicant has failed to demonstrate that other considerations clearly outweigh the identified harm to the Green Belt and, as such, the proposed development is therefore contrary to Government guidance contained within the National Planning Policy Framework, Planning Policy for Travellers Sites and saved policies GB2A, GB5, GB7A and H10A of the adopted Local Plan and Alterations.
- 2 The proposed material change in the use of the land as a residential traveller site would involve the adaptation and reuse of the existing building on the land and the stationing of four additional caravans for residential use. The use of the land as a traveller site would exacerbate the over-concentration of existing traveller site uses in the Parish of Roydon and the adjacent Parish of Nazeing, when compared with the rest of Epping Forest District. As such, the proposal represents an unsustainable form of development that will result in an adverse impact on the environment and infrastructure of these parishes and is therefore contrary to Government guidance contained within the National Planning Policy Framework, 'Planning Policy for Travellers Sites' and saved policies CP1, CP2, CP3 and H10A of the adopted Local Plan and Alterations.

## **WAY FORWARD**

The Council acknowledges that the specific health needs of the Applicant, Mrs Kathleen O'Driscoll, are material planning considerations weighing in favour of an application for temporary planning permission for the adaptation and reuse of the existing building on the site for residential use by the applicant. The Council also acknowledges that the adaptation and reuse of the existing building on the land to provide temporary residential accommodation for the Application would not constitute inappropriate development in the Green Belt.
