These groups offer a wide range of services to the district residents – from managing playing fields for different organised groups and local residents, residents and visitors to the Loughton area and physical activity.</p> <p>2 applications have been deferred due to further information to be received from the groups.</p> <p>1 application has been had a change of use to its funding allocation agreed.</p> <p>The groups that receive funding support all ages of the community.</p> <p>All groups that are successful in their grant application will receive a visit to ensure that the funds have been appropriately spent.</p>
