DISTRICT OF EPPING FOREST LOCAL HIGHWAY PANEL – 23 MARCH 2010 REPORT BY AREA HIGHWAY MANAGER – ESSEX COUNTY COUNCIL

PROGRAMME OF WORKS 2009/2010

1. Purpose of report

- To provide Members with a report on Highway issues within Epping Forest District.
- To provide sufficient information on schemes so that decisions on local priorities can be made.
- Members are invited to offer suggestions and requests for future works.

2. Background

Essex County Council is currently nearing the end of the financial year. The majority of the capital highway maintenance schemes have been completed and progress is being made on finishing the traffic management improvement schemes.

A number of maintenance and traffic management improvement schemes have been approved by the Panel for the 2010/11 programme of works and progress is currently being made by Officers in ensuring viability and accurate cost estimates.

At the time of writing, budgets for the 2010/11 financial year have not been confirmed however it is hoped that this information will be available at the meeting.

1. Maintenance

The current programme of Highway Maintenance Initiative schemes is shown in **Appendix A.**

The schemes to Earls Path, Loughton and Hastingwood Road, North Weald shall be postponed so that minor overspends on higher priority schemes can be supported and so will be considered for inclusion in the 2010/11 programme of works. These schemes are currently ranked a Priority 2 and a Priority 1 respectively.

2. Improvements

2.1. Traffic Management Improvements

Current traffic management improvement schemes are shown in **Appendix B**

Roydon and Nazeing – The Executive Decision from the Cabinet Member for Highways and Transportation has been received and the Traffic Regulation Orders have been formally advertised. The speed limit orders have now been sealed, however the weight restrictions received some objections. Officers will continue to work to progress these further with a view to them being sealed at a future date.

The safety audit for the build-out designs has been completed, an exception report was produced and the details have been finalised. These works have now been completed and are listed as follows:

- Installation of 2 priority give-way build outs
- Installation of 2 new vehicle activated signage
- New speed limits and associated signage
- Resurfacing and new road markings
- · Gullies repaired and cleaned
- 2 new lamp columns

Roydon and Nazeing, Positive signage review:

An audit of all HGV signing in Harlow, Nazeing, Roydon and Hoddesdon and existing routing has been completed.

The preferred HGV route to direct HGV through-traffic away from Nazeing and Roydon Village has been agreed. Collaboration and agreement with Hertfordshire Highways on the scheme design has also been achieved.

The designs for the scheme have been completed and are ready to be manufactured.

It is unlikely that the installation of the manufactured signs shall be completed this financial year and will therefore need to be programmed early in the 2010/11 programme.

After completion of the scheme, it shall be monitored and assessed to ensure its effectiveness. Any further design work will be carried out if deemed necessary. Discussions are underway with Essex Police and Trading Standards, with regards to the enforcement of the proposed weight restrictions.

2.2. Uncontrolled Crossing Improvements

The budget allocation has been fully committed and the works are all complete.

2.3. Safer Roads Programme

The majority of these schemes have been completed. Those schemes outstanding should be complete by the time of the meeting.

2.4. Area Identified Schemes

Pudding Lane, Chigwell: The majority of this scheme is complete, with some signage works to be completed. The delay in completing the work has been brought about by a road traffic accident last month, at which a vehicle struck the column to which new signage was to be placed. Another order has been made to replace this column and Officers are liaising with the Contractor to have this installed as quickly as possible. This scheme has used the full allocation of funding.

B175, Stapleford Abbotts: The design is complete, but Contractors are unable to complete this within the current financial year and so this will be promoted for inclusion early in the next financial year's programme of works.

2.5. Public Rights of Way Improvements

This budget has now been fully committed and the works are now complete on Byway 21, Fyfield.

At the last meeting of the Panel, Members requested information on the proposed schemes for the 2010/11 programme of works. Officers have put forward schemes for Moreton 1 and Abbess, Beauchamp and Bernes Roding 31 as their preferred schemes for the 2010/11 financial year. At the time of writing confirmation of funding has not been received, however details of the schemes are provided below:

Byway 31 Abbess, Beauchamp & Berners Roding (Elm Cottage Lane)

The section of this byway requiring attention is an unhardened green lane, approximately 1km in length. The lane contains approximately 30 veteran trees, of which 25 are pollards, some of which are marker trees for old parish boundaries. Ancient woodland indicators are present in the lane, and the hedgerows bordering it are between six and eight hundred years old, according to Hooper's Rule. The lane is a Local Wildlife Site.

Byway 31 links two minor roads, one of which would otherwise be a 'dead end' and effectively is for motorised vehicles, other than four-wheel drives. It also links with Public Footpaths 37, Willingale and 43, 44 & 49 Abbess, Beauchamp & Berners Roding and is close to other byways which form part of the Essex Way. Local residents have reported that this network is used by motorcycle groups for organised events involving large numbers of juveniles.

Motorised vehicular use has resulted in the un-surfaced section of the lane becoming deeply rutted, rendering it difficult and at times impassable for other users – complaints have been received from horse riders. Therefore, works are necessary to fill in the ruts with hard material and carry out some localised ditch clearance. Also there would appear to be a requirement for a culvert crossing at the point where Byway 31 turns north onto a metalled farm road.

Byway 1, Moreton (North Lane)

This byway is an unhardened green lane, approximately 1km in length, linking the minor roads, Maltings Hill and Harlow Road, Moreton. It also links with Public Footpaths 2, 3 & 4, Moreton. The lane has been in existence for at least 200 years and appears on the 1805 Ordnance Survey map, but is probably ancient and crosses the route of a Roman road running between London and Dunmow.

North Lane is on high ground, above Moreton village and forms a significant feature in the landscape, rising to high mid-point of 80 metres, which affords good views of the surrounding countryside. The lane is a Local Wildlife Site.

The eastern section of the lane has suffered some damage to the surface, due to vehicular use. In particular, a sunken section near the eastern end is poorly drained and shows evidence of some attempted surfacing work with unsuitable material. This section is difficult for walkers and horse riders to negotiate in winter and there is evidence of use on an adjacent farmland conservation strip. Therefore works are necessary to surface this section with suitable hard material and carry out drainage improvement works.

2.6. Passenger Transport Improvements

Officers are able to report that this budget allocation has been fully committed and all works are now complete.

Safer Journeys to School Highway Works

This budget allocation has been fully committed and all works are now complete.

3. Community Initiative Fund

2.7. 2008/09 applications

Nine projects were approved in 2008/09 within the Epping Forest District for delivery within the 2009/10 programme of works and these are detailed within **Appendix C.**

Loughton; **signage**: Officers have liaised with the Parish Council, Essex County Council Cycling Officers and the Corporation of London in developing the design of the signage required for walkers and cyclists. Agreement has now been received and Officers expect works to be completed by the end of March 10.

Waltham Abbey; signage: A survey on the street columns has been completed and it concludes that the additional signage to the columns can be achieved. The order has been placed and start dates on site are being agreed with the Contractor.

Stapleford Abbotts; village gateways: The order has been placed and Officers expect works to be complete by the end of March 10.

2.8. 2009/10 applications

The bidding process for 2009/10 has now closed. Officers received a total of 21 applications, of which 4 schemes did not meet the criteria. A total of 17 applications, which met the criteria, at an overall value of £435,000 were submitted to the CIF Co-ordinator at County Hall. Schemes ranged from speed reduction schemes, installation of pedestrian crossings, improving footways and installing bollards.

As such a large amount of applications were received from the Epping Forest District, the CIF Coordinator shall be contacting applicants who have submitted more than one application, inviting them to pick one of their projects to go forward to the panel, with one in reserve. This, it is hoped, will help to accelerate the judging process, so that the schemes can be progressed as quickly as possible. Members will be updated once successful bids are known, hopefully early in the new financial year.

4. Localism Budget

The Localism Revenue schemes address a number of highway problems and incorporate a wide variety of measures including parking and speed restrictions, improvements to or introduction of, pedestrian crossing facilities and other traffic management improvements.

Current projects are detailed in Appendix D.

However the following schemes are incomplete and need to be considered for inclusion in the 2010/11 programme of works.

London Road, Abridge	New speed limit	Indicative costs:
	40mph buffer	£2,500

The design for this scheme is complete; however final installation cannot be achieved within the financial year owing to the process of the traffic regulation order. Consideration by Members needs to be made for the inclusion of this in the programme of works for 2010/11.

The section of London Road southwest of the caravan park is currently subject to a speed limit of 60mph. This section of road is fronted by many residential properties, which gradually change to a more rural frontage along the most south-westerly section.

The proposed reduction in speed limit from 60mph to 40mph will not only create a buffer zone for the existing 30mph speed limit through the village, but will also aim to improve road safety for both drivers and pedestrians by reducing vehicle speeds along this residential section of carriageway.

A speed assessment has been carried out and established a mean average speed of 36.9mph and the personal injury data states 18 collisions in a 5 year period.

Officers have completed all studies, assessments and the design. The traffic regulation order is to be formally advertised by the end of the 2009/10 financial year. But to complete this scheme with the implementation of the traffic regulation order, the removal of some old signage and the installation of new signage, a budget of £2,500 would be required.

Some objections have been received for some of the proposals. Action on these comments and the installation of the bays cannot be achieved in the current financial year due to delays in processing of the traffic regulation order and so consideration by Members will need to be made for the inclusion in the 2010/11 programme of works. This is discussed in more detail later in the report.

Officers have prepared these works ready to order, however the implementation cannot be achieved in the current timescale. It is advised that Members consider this for inclusion in the 2010/11 programme of works.

Hastingwood Road, Mill Street and Harlow	Speed Limit review	Indicative costs:

Speed assessments have been completed, but the designs are still to be finished. It is anticipated that this scheme cannot be achieved in the current financial year and so Officers recommend Members consider this for inclusion in the 2010/11 programme of works.

The speed assessments at these locations have been completed. The results indicate:

From Hastingwood Road to junction with Harlow Common:

Mean average speed of 36.9mph

85 percentile speed of 43.7mph

The recorded personal injury collisions along this stretch shows to be 1 in 3 years

Hastingwood Road, from A414 to Willow Place

Mean average speed of 41mph

85 percentile speed of 48.7mph

The recorded personal injury collisions along this stretch shows to be 4 in 3 years

Preliminary investigations have been completed for Foster Street and Harlow Common and conclude that they are appropriate for inclusion in this scheme.

The design is still to be completed, but to complete the design, the traffic regulation order and the installation on site, a budget of £12,000 would be required.



5. Area Parking Review

Buckhurst Hill

The draft traffic regulation orders are currently being completed by Officers.

Epping

The draft traffic regulation orders have been completed and are being checked by Officers. These shall then be issued to the Essex County Council Legal and Administration department to formally advertise the orders.

Loughton Broadway

Meetings between both Officers and Members of Essex County Council and Epping Forest District Council have taken place to discuss the outcomes and recommendations of the consultation. It has been identified that further investigation is required on possible alternatives. This pertains to draft proposals recently circulated by the Department for Transport (DfT) on parking permit zones and signs. Currently such schemes require individual authorisation from the DfT and this can often be a very time consuming affair, hence Officers were encouraged to hear that such specific authorisation may not be required if the draft proposals are approved. This will improve the efficiency and progress of this scheme, but if it is rejected it is inevitable that each location will need to be applied individually.

In addition to this investigation, initial site visits have been carried out and design work has commenced.

6. Epping Forest Transport Strategy

The resurfacing works to Pynest Green Lane, High Beach has now been completed. Other localized repairs have also been identified and these works shall be completed by the end of this current financial year, including refurbishment of the speed limit signage.

7. Conclusion

Members are invited to discuss the report and offer comments pertaining to current works and programming.

DISTRICT OF EPPING FOREST LOCAL HIGHWAY PANEL – 23 MARCH 2010 REPORT BY AREA HIGHWAY MANAGER – ESSEX COUNTY COUNCIL

PROPOSALS PROGRAMME OF WORKS 2010/11

1. Maintenance

The budget allocations for the 2010/11 financial year have not yet been disclosed.

At the last meeting of the Panel it was agreed to progress the Priority 1 and 2 schemes once confirmation of the budgets are released.

Due to recent weather conditions, additional sites have been identified and added to the lists of proposed sites, this will be presented to the Members at the meeting.

2. Traffic Improvements

Capital budget allocations have not yet been declared for traffic management improvements at the time of writing; however Officers have been carrying our further investigation work to those schemes approved by the Panel in preparation of this information.

2.1 High Priority Schemes Approved by the Panel

At the last meeting of the panel it was agreed by Members to promote the scheme for a signal controlled crossing at B173 Manor Road, West of Tomswood Road, Chigwell and changing the priority of the junction at Downhall Road/Little Laver Road/Watery Lane, Matching to a high priority.

The schemes approved by the Panel are listed and detailed below:

- 1. Downhall Road/Little Laver Road/Watery Lane, Matching Realignment of priority junction
- 2. St Leonard's Road, Nazeing Village gateway and repositioning of VAS
- 3. **B184**, Fyfield 2 x VAS
- **4.** Sawbridgeworth Road, junction with Sheering Lower Road, Sheering Extension of an existing 30mph speed limit
- 5. Westbury Road, Buckhurst Hill Build outs
- 6. Church Road and Brook Road, Buckhurst Hill Pedestrian phasing on existing traffic signals
- 7. Manor Road, junction with Vicarage Lane, Chigwell Junction improvements
- 8. Hemnall Street, junction with Grove Lane, Epping Installation of pedestrian crossing
- 9. A121 High Road, Loughton Signal controlled crossing
- 10. Crooked Mile, N of Saxon Way, Waltham Abbey Signal controlled crossing
- 11. Crooked Mile, N of Monkwood Avenue, Waltham Abbey Signal controlled crossing

- **12. B173 Manor Road, W of Tomswood Road, Chigwell** Signal controlled crossing **13. Church Hill, Loughton** Signal controlled crossing
- **14. Station Road, Epping** Signal controlled crossing/pedestrian refuge

Downhall Road/Little Laver Road/Watery	Re-alignment of	Indicative costs:

The aim of this scheme is to divert traffic to a more suitable road by changing the priority at the junction and enhancing the signage.

The accident data has been received for this location and it has established that there have been no recorded personal injury collisions in the vicinity.

Initially Officers have some concerns that turning of large vehicles such as HGVs and tractors may not be possible or will raise safety concerns. This is a rural area and these types of vehicles frequent these roads, and not only the length but the width of these vehicles must be considered in the design. Officers have carried out an 'Autotrack' assessment; a computerised assessment which models the swept path of all types of steered vehicles. This has shown that HGV's either cross the centre line or cut across the verge.

In addition, centre lines and cat's eyes would also be required to highlight the trajectory of the new alignment of the bend and to delineate the new road layout, after historically Little Laver Road giving way to Watery Lane/Downhall Road.

A meeting with Essex County Council Road Safety Engineers has taken place on site. They have advised that the following measures are necessary to facilitate the scheme operating safely:

- The vegetation on the corner adjacent to 'Corner House' needs to be removed to increase and improve the sight lines. The Highway boundary will need to be investigated to establish those responsible for this.
- Double yellow lines will need to be installed opposite the junction to prevent the current parking at this location.

At the last meeting of the Panel Members queried whether some routes could be removed from satellite navigation systems. The Local Government Association is petitioning the Government requesting that legislation is enacted to deal with the issue of vehicles using inappropriate roads as a result of satellite navigation devices, these proposals also includes the granting of powers to highway authorities to install signage to warn off inappropriate roads that may show up on these types of devices.

St Leonard's Road, Nazeing Village gateway and repositioning of VAS £15,000

As reported at a previous meeting of the Panel, the existing Vehicle Activated Sign has been located at a point which meets with Essex County Council policy and the speed data received at the time, which deems it to be the most suitable.

It is anticipated the location of the new gateways will be adjacent to the current red road surfacing, however owing to the narrow width of the verge on one side of the road, it is anticipated that this gate may need to be manufactured to a bespoke design (an example is shown below).

A speed survey is being ordered by Officers and the results shall be presented at a future meeting of the panel. Officers shall also be arranging a meeting with the Parish Council to discuss possible locations for the VAS signs once the conclusions of the speed survey have been received.



An initial speed limit survey is underway for both a 30mph and 40mph speed limit and an initial site investigation has been carried out.

The accident data has been collected and it concludes that there have been no recorded personal injury collisions at this location.

The results of the speed survey shall be presented at a future meeting of the panel.



Westbury Road, Buckhurst Hill	Build-outs	Indicate cost:

As a result of the recent Buckhurst Hill parking consultation, the Officers received reports of significant abuse of the one-way section of Westbury Road between Scotland Road and Palmerston Road. The construction of build-outs at the junction with Russell Road and prior to the junction of Scotland Road is designed to aid the conspiculatity of the one-way system and hence reduce non-compliance.

Further surveys will be undertaken, including up to date accident data.



Church Road and Brook Road, Buckhurst	Pedestrian Phasing	Indicative Cost:
Hill		£40,000

This scheme is to introduce an additional pedestrian phase to the existing traffic signals.

An assessment and feasibility analysis will be required prior to any design work at this location. For this to be progressed an order would need to be placed with a partnership organisation for £5-10,000, this would be deducted from the budget allocation for Localism. It is anticipated that the results of such assessments will not be completed until approximately 6 months into the new financial year and if this were the case, it is anticipated that construction on site may not be achieved until the 2011/12 programme of works. Officers therefore seek Member comments on whether this scheme shall be progressed as a 'design only' scheme for 2010/11.



Manor Road, junction with Vicarage Lane,	Junction	Indicative costs:

A request was made to improve the junction at this location. Officers are currently forming some preliminary designs to test turning movements to ascertain which design will be the most feasible.


Additionally Officers have also requested plans showing the location of the BT apparatus located in the vicinity. Members are advised that if diversion works are required there may be large costs associated with this that may render the scheme prohibitive. Members will be advised as this information is received.

Officers are currently arranging a small topographical survey. This is required to gain sufficient data to progress the design further.

Officers recommend that before this scheme is progressed to a detailed design stage, a site meeting is undertaken with all interested parties to look at the feasibility of the suggested improvement.

A pedestrian survey has been carried out at this location and a suitable location was identified North East of The Uplands. Further investigation of a suitable location is required to ensure that installation will be possible and that traffic impact on nearby junctions is limited.

CONSENTED DEVELOPMENT ~ WORKING ON THE HIGHWAY REPORT BY AREA HIGHWAY MANAGER – ESSEX COUNTY COUNCIL

Background

Any housing development, whether it is the building of one house or a housing estate of 100 properties, is required to make a planning application to Epping Forest District, as the Local Planning Authority.

Notification will be received by the Essex County Council, as the Highway Authority if:

- The development within an urban area is for 5 or more properties
- Or the Planning Department feel the development may have significant impact on the highway.

<5 Properties

Typically, a development of 5 properties or less will not be notified to the West Area Office. There are no statutory requirements for the developer to contact the Highway Authority, unless the development specifically needs to carry out works in the highway.

Should the developer need to work in the highway (for example, to change the vehicle crossover) they are required to contact the Highway Authority to seek formal agreement.

Where defects or other problems have occurred on the highway through the works carried out on such a development, these are normally identified either by the Highways staff in the course of their normal duties or through enquiries received from members of the public.

Members should note that because the developments are small in nature, Officers may not have been aware of their commencement, given that they are often 'stop/start' in nature. Additionally even though Officers may have been made aware of the site via lists of planning applications where permission has been granted, this does not mean the development has commenced. Officers are looking at ways to improve this system with colleagues at Epping Forest District Council.

>5 Properties

In larger developments of 5 or more properties and where work is required in the highway to necessitate the scheme, approval must be granted by Essex County Council, through a Section 106 agreement under the Town and Country Planning Act 1990 or a Section 278 agreement under the Highway Act 1980.

Section 106 agreement

Section 106 of the Town and Country Act, in conjunction with Department of Environment Circular 5/05, allows for Essex County Council and persons interested in land to agree contributions, arrangements and restrictions as Planning Agreements or Planning Obligations. Applicants can offer such agreements unilaterally or negotiate and agree them as support for their application to make it accord with local planning requirements, but without some of the rigorous controls of Planning Conditions under s 70(1).

Monies are paid by the developer to Essex County Council in order to offset the costs of the external effects of development. For example, if a developer were to build 100 new houses, there would be effects on local schools, roads etc., which Essex County Council would have to support. In that situation there might be a Section 106 agreement as part of the granting of planning

permission. The developer might agree to make a contribution towards the provision of improving the footway or road network.

Section 278 Agreement

The Section 278 agreement is a facility to allow private developers to either pay for or carry out offsite works to public highways (for example, creating junction improvements or the introduction of pedestrian crossings).

Developers building these many properties are typically public and community responsive. Through experience they contact Officers prior to any works, to discuss the scheme and to carry out pre-condition surveys. They are pro-active to ensure site safety and are receptive to issues raised throughout and after the construction process. For example, carrying out temporary repairs throughout the projects life span and then undertaking permanent repair works once the development is complete.





UTILITIES WORKING IN THE HIGHWAY REPORT BY AREA HIGHWAY MANAGER – ESSEX COUNTY COUNCIL

The power of Utilities to work in the public highway

An individual or company can only work in the highway if:

- They hold a Section 50 Street Works Licence
- Are a Statutory Undertaker

A Section 50 Street Works Licence can be granted to a private individual or company to allow them to place their apparatus within the highway and thereafter carry out acts of maintenance upon it and their works shall be declared to all other parties who may be working in or have apparatus in the vicinity.

Work identified

The Statutory Undertaker is required to serve notice on the Highway Authority when works are identified as being required. The details of the notice and the works, including the location and duration are logged to the Street Works Register with a unique works reference number; a database which is shared with all those working in the Highways of Essex. This database connects with the Statutory Undertakers database of works; two-way communication between them ensures that all information and comments are kept up to date. Any comments made about the notice (e.g. that the commencement date is unsuitable) are then recorded on each database and action or changes are made as appropriate.

Types of notifications

Emergency – where risk/danger to persons/property is present Notice: up to 2 hours after the works have commenced Duration of works: until the location is made safe and poses no further danger

Minor

Notice: 3 days advance notice of the works commencing

Duration of works: up to 3 days

Validity period: ±2 days*

Standard

Notice: 10 days advance notice of the works commencing

Duration of works: 4-10 days Validity period: ±5 days*

Major

Notice: 3 months advance, then a subsequent 10 days advance notice of the works commencing

Duration: 10 days + Validity period: ±5 days*

* If the individual or company fails to commence the works within the validity period then the notice is cancelled. Should the work still need to go ahead, the process of giving notice will need to be reapplied.

The Works

Street Works carried out in the Highway are governed by:

- The New Roads and Street Works Act 1991
- Traffic Management Act 2004

The following Codes of Practices, issued by the Department for Transport (DfT) and the Highways and Utilities Community (HAUC), also apply:

- Coordination of Street Works
- Safety at Street Works and Road Works
- Practical Guide to Street Works
- Specification for reinstatement of openings in Highways

If the works go on longer than anticipated

The Statutory Undertaker will be expected to contact the Highway Authority and seek agreement for an extension in the duration of the works.

If the works continue beyond the end date and no agreement has been made with the Highway Authority, then a Section 74 Charge will be issued. This charge will also be served if equipment is left on site (e.g. barrier or signs). After an 'over stay' charge has been issued; the site is monitored daily and a charge applied daily (i.e. £100 – 250+), dependent on the classification of road, until such time as the site is cleared.

Completion

At completion of the works, a Completion Notice is given. All works within the Highway carry a guarantee by those who have carried out the works, where any repairs to defects will be carried out at their expense:

<1.5m in length: 2 year guarantee >1.5m in length: 3 year guarantee

Inspections

The New Roads and Street Works Act 1991 and the subsequent Traffic Management Act 2004 dictate that a sample of 10% of notices for each individual Statutory Undertaker be taken, based on an average of the 3 years previous works. Officers also respond to third party enquiries that involve utility works.

The Street Works Register randomly selects samples of previous works for the Highway Authority to inspect. The inspections, which are funded by the Statutory Undertaker, are categorised as follows:

Category A: Inspection whilst works are in progress

Category B: Inspection within 6 months of permanent or interim reinstatement has been completed

Category C: Inspection carried out within 3 months preceding the end of the guarantee period

The results of the inspections are logged onto the database against the unique works reference for the job and a notice is served to the Statutory Undertaker:

- Pass
- High Risk Failure (i.e. it poses risk/danger to persons/property)
 - o The works must be remediated within 2 hours
 - The inspector shall stay on site until the works are completed

- In some cases the Highway Authority may instruct their own Contractors to carry out the works within the timescale
- Low (e.g. reinstatement works not satisfactory)
 - o The works must be remediated within 10 days
 - A follow up inspection shall be carried out

All failed inspections are funded by the Statutory Undertaker, including any follow up inspections which may be required.

Defective Apparatus

Statutory Undertakers have a duty under the New Roads and Street Works Act 1991 to maintain their apparatus (e.g. covers and cabinets). A Section 81 Notice may be served should any be found defective. It may:

- state that the Statutory Undertaker must attend within a specific timeframe to remediate the apparatus,
- inform them that the Highway Authority's own Contractors will attend to carry out the remedial works,
- or request that the Statutory Undertaker confirms with the Highway Authority of any actions they are going to take.

Coordination of works

In addition to the Area Offices who monitor the notices received, a quarterly coordination meeting is held where representatives of the Statutory Undertakers and the Area Offices attend and declare all major works for the forth coming year. This is a forum whereby clashes in works can be discussed and an opportunity to review the records of defects.

Improvement Notice

Should a Statutory Undertaker fall above a certain percentage of class of defect, they will be issued with an Improvement Notice. They will be called to County Hall and asked to discuss their routine failings. They will be expected to produce a 3 month plan which will demonstrate that they can make improvements and their progress will be monitored. Should the Statutory Undertaker continue to produce failure notices, further action will be taken.

The Highway Authority can also state which Sub-Contractors cannot be used within certain areas or districts, due to historical poor performance.
