PART C - GENERAL INFORMATION

1. PAVEMENT LICENSES

The Business and Planning Act 2020 received Royal assent on 22 July 2020 and has been introduced to assist businesses in recovery from the impacts of Covid-19. Measures include ability for bars, pubs and restaurants that had on site alcohol licences to be able to sell off site and to allow premises the flexibility to seek licences for outdoor seating.

A Temporary Pavement licence gives permission for removeable tables, chairs and other furniture to be used on the pavement outside a business to allow customers to enjoy Al fresco dining whilst also helping businesses to observe the social distancing rules. Eligible businesses include pubs, cafes, bars, restaurants, snack bars, coffee shops and ice cream parlours, and the licensing scheme continues until 30 September 2021.

The licence application process is fast tracked, all correspondence is electronic, and councils must determine an application within 14 days of receipt. Any applications not approved within the statutory timescale are deemed approved.

Cabinet agreed at its meeting on 20 July 2020, in preparation for the introduction pavement licence applications, and in order to meet the tight deadlines imposed by the new licensing regime, that the decision to determine an application will be made, where there are no objections, by the Service Director. Where there are objections, the Portfolio Holder for Commercial and Regulatory Services or the Leader of the Council will be consulted as well as the Chair or Vice Chair of the Licensing Committee before a decision can be made. In addition, all consultations will be carried out by electronic and digital means only and all applications will be made online.

It is also confirmed that all ward members will be consulted by email on any applications related to their ward.

Full details about the new Temporary Pavement Licences are available on the <u>website</u>, including the EFDC Pavement Licence Policy, the standard licence conditions (that will be subject to change depending on premises specific circumstances) and the link to the on-line application form.

HIGHVAYS HIGHLIGHTS

DESPITE THE VIRUS: HIGHWAYS IMPROVEMENTS IN FULL SWING

COVID-19 remains a serious threat and last month we reported on the first steps we have taken with local councils in a number of urban Essex locations to provide safer highway areas for people to move around and social distance. We have tweaked some details as we gained user feedback and we are now preparing ambitious bids for the second tranche of government money to widen the scope and permanence of schemes that will encourage more active, healthier forms of local travel such as walking and cycling.

In support of this desire we have also launched our Stop. Swap. Go! campaign, designed to encourage people to rethink how we get about for short journeys, to help ease congestion, clean up air pollution and improve our health. You can read more about Stop Swap Go inside. July has also been a very busy month for all sorts of other highway progress across the county.

Essex Highways 'Press Releases' page (which also has back issues of Highways Highlights) carries announcements on many of them, including A133 improvements at Weeley & Frating; public launch of plans for Chelmsford NE Bypass and Beaulieu Station and, right at the end of the month, the launch of our latest County Member led pothole repair scheme, enabling all County Councillors to work with their local councils to nominate particular potholes they would like fixed beyond the ones we have already planned for repair.




THE STOP. SWAP. GO! 60 DAY CHALLENGE IS HERE...

WORTH SPREADING THE LOVE - TO RIDE!

The Government is now investing heavily in getting more of us cycling, and those who do cycle, doing more. One of Essex's key investments is a partnership with Love to Ride, a supportive and encouraging cycling community, with our own local incentives and contacts.

People can register and then record their rides, praise and encourage others, enter prize draws and get ideas for rides and cycle group details. Walking is just as important and very much encouraged by **Active Essex** which works to support everyone of all ages, sizes and abilities to become more active and more healthy.





USE WHAT3WORDS ON ESSEX HIGHWAYS WEBSITE TO REPORT EXACT SITE OF POTHOLES AND OTHER ISSUES

When a councillor or a member of the public wants to report a pothole or any other problem on a road or public footpath, they now have the option to give the precise location using something called 'What3Words'.

Anyone with a smartphone can download the What3Words app which shows you exactly where you (and the pothole) are and three words defining a unique location.

You can then enter those three words in the search bar when you report your concern online. This may be particularly helpful in rural areas. Our inspectors can get straight to where the problem is, saving time and money by avoiding ambiguity. More info here





POTHOLES, PAVEMENTS DRAINS AND STREETLIGHTS FIXED IN THE MONTH...

Potholes fixed per district/city/ borough in June are as listed below:

When considering these numbers, remember that there are many more miles of road in Uttlesford than in Harlow, for example, and the balance of types of road (main, secondary, local) are different too, so a direct comparison is misleading.

11,793 drains were cleared in June, including 2,247 across Basildon, Brentwood and Rochford districts along the A127 including slip roads and circulatory junctions.

In July regular district by district clearing of drains on local roads continues in Basildon, Chelmsford, Colchester and Uttlesford. Street lights fixed in June are included here for the first time.

For more efficient working (saving crews travel time) lights are repaired in local areas within a district before moving on to the next district, unless there is, for example, a failure of several lights at a busy junction which are repaired as a priority.

Some lights fail due to power supply issues which must be repaired by the electricity supplier – this can take time.

EFDC Safer Spaces Commonplace report 3 August 2020




The **EFDC Safer Spaces during COVID-19** commonplace platform launched on the 13 June 2020. Up to 3 August there were 2,835 visitors. This has increased by 302 in the 2 week period since 20 July 2020.

Total contributions are now at 714 which is up by 15 since 20 July. The contributions are made up of 203 comments and 511 agreements. 100 people have subscribed to receive the project news by email.

Of the 292 respondents, 178 confirmed their email address to be genuine and are public. There are 31 comments and 97 agreements from 114 unconfirmed respondents which are not public.








Visitors over time



Demographics


What is your age group?

The age group most represented in comments is between 55-64 years. Only 6% of respondents are younger people below the age of 35. 35% are unknown.




What is your gender?

38% of respondents identified themselves as female and 25% male. 36% are unknown or prefer not to say.




What is your connection to the area?

What is your normal mode of transport?


53% car, 27% walking; cycling and public transport 9%. 33% unknown.



Transport and air quality


If you have a car, how do you expect the amount you drive it to change in the coming months compared with your pre-Covid use?

During this recent period of restricted travel, have you personally noticed a difference in the air quality in your area?


42% said air quality is better, 23% haven't noticed a difference, 1% worse. 34% unknown.




Support for interventions and measures

Do you support temporary measures to reduce traffic speeds and/or volumes to help aid social distancing and keep those walking and cycling to shops and services safe?




Looking forward to the next 12-24 months, would you support measures that seek to reallocate road and parking space for walking and cycling space more permanently?

How could we make it better?

When asked How could we make it better? The top 10 improvements were:

- 1. Slow down traffic 83
- 2. Reduce speed limit 67
- 3. Restrict vehicle access 38
- 4. More space for walking 34
- 5. Keep the pavement clear 29
- 6. Cut back foliage 27
- 7. More space for cycling 24
- 8. Restrict parking 23
- 9. Safer junction 23
- 10. Add crossings 22

Actions

Some of the comments which are not primarily to do with social distancing should be reported direct to the relevant body to action. These include:

Roads and pavements
