Regulatory Committees

(a) Licensing Committee

Terms of Reference

- (1) The full Committee shall comprise 15 Councillors appointed by the Council at its annual meeting, including a Chairman and Vice-Chairman.
- (2) For the functions set out in Appendix 1, and the legislation listed in Appendices 2 and 3, a sub-committee consisting of no more than any three Councillors drawn from the members of the full Committee shall be formed. Any such sub-committee shall include, by rota, one of the six Licensing Sub-Committee Chairmen appointed at each Annual Council meeting.
- (3) The Quorum for the Committee is set out in the Rules set out in Part 4 of this Constitution save that no business shall be transacted unless either the Chairman or Vice-Chairman of the Committee is present.
- (4) The Committee and sub-committees shall have full authority to hear and determine licensing applications.
- (5) The Committee and sub-committees shall be further empowered to determine appeals made against the decisions of the Service Director (Commercial and Regulatory Services) taken under delegated authority on licensing applications. (See Council delegation schedule for more details).
- (6) The Committee shall at all times carry out its duties solely within the policy from time to time determined by the Council and shall conduct its proceedings in accordance with the requirements set out in Appendix 4 (Conduct of Business by the Licensing Committee and Sub-Committees).
- (7) The Licensing Committee shall take no part in the production or revision of the statement of licensing policy made under Section 5 of the Licensing Act 2003, however, they may determine policy under the legislation listed in Appendices 2 and 3 to this Article.
- (8) To be responsible for the consideration and approval of Designation Orders under Section 13 of the Criminal Justice and Police Act 2001 (Exercise of Controls over the consumption of alcohol in Public Places).

PART A – CONDUCT OF BUSINESS BY LICENSING COMMITTEE AND SUB-COMMITTEES

All references to committee in this annex shall be taken to infer a reference to the associated subcommittees.

1. General Conduct

- 1.1 All hearings of the Licensing Committee under the Licensing Act 2003, are to be held in accordance with the Personal Licences, Hearings, Premises Licences and Club Premises Certificates, and Licensing Register Regulations, made under the Licensing Act 2003.
- 1.2 The Council's Constitution shall regulate the conduct of and debate at meetings.
- 1.3 In the case of hearings under the Licensing Act 2003, the Committee shall only consider those matters relevant to the licensing objectives as set out in the Licensing Act 2003 and the statement of licensing policy adopted by the Council.

2. Declarations of Interest

2.1 Members of the Committee are subject to the Council's Code of Conduct.

3. Participation in the Hearing

- 3.1 Debate shall be restricted to members of the Licensing Committee. Where a local ward member, not being a member of the Committee, wishes to participate in the hearing, they may do so only with the permission of the Chairman and their participation shall be subject to the same rules as are applied to any other witnesses to the application.
- 3.2 In hearings other than those under the Licensing Act 2003, where a ward member is a member of the Committee, and wishes to object to the application, the member shall give 14 days' notice of their intention, and shall play no part in the decision-making process of the Committee. In hearings under the Licensing Act 2003, those named as responsible authorities and interested parties in the Act may only make representations within the time limits set out in the relevant statutory provisions.
- 3.3 All persons participating in the hearing shall be made aware of the limitations or scope of statements that will be acceptable and, in particular, that statements should be factual or a fair statement on a matter of public interest.
- 3.4 In the case of any hearing pursuant to the summary review procedure under the Violent Crime Reduction Act 2006, the membership of any Subcommittee adjudicating on such a review shall comprise any three members drawn from the Licensing Committee subject to the proviso that no member should serve more than one hearing.

4. Attendance of the Public

4.1 The Council's Constitution and relevant statutory provisions relating to the admission or exclusion of the public shall apply to all meetings of the Licensing Committee.

5. Natural Justice

5.1 There are two elements to natural justice:

(a) Fairness

- (i) All persons affected by the decision or in the case of matters associated with the Licensing Act 2003, those named as responsible authorities and interested parties in the Act, will be allowed a hearing before a decision is made.
- (ii) Only objectors who can show clearly that they are affected by a decision shall be afforded the right to be heard or, in the case of hearings under the Licensing Act 2003, only those named in the Act as responsible authorities or interested parties.
- (iii) All information shall be made available, where possible in advance, to the applicant and the Committee.
- (iv) All members of the Committee shall be present throughout the hearing of a particular application. Where a member arrives late or leaves during a hearing of a particular application, that member shall play no part in the decision-making process. Where an application is adjourned it shall be continued by the same members only, and no others.
- (v) The Committee shall have discretion in respect of 'late' objections. Such objections shall be clearly marked on the agenda as such and the Committee shall decide on their acceptability. The applicant shall be advised of any late objections. In the case of representations made in relation to the Licensing Act 2003 applications, these shall only be accepted in accordance with the relevant statutory provisions.

(b) Prevention of Bias

- (i) The rules on the declarations of interest shall be firmly applied.
- (ii) If the Committee moves into private session to consider its decision, it shall be accompanied only by its advising officers, none of whom shall have taken a substantive part in the hearing, and shall play no substantive part in the decision-making process.

6. General Procedures for Hearings

- 6.1 The following procedural requirements shall be followed at all times:
 - (a) There shall be no recommendation from officers on the agenda;
 - (b) The Committee shall be supplied with copies of all relevant documentation and the process and order of procedure shall be as follows:

- (i) The Chairman will open the meeting and introduce persons as appropriate asking applicants and representatives to identify themselves.
- (ii) The Chairman will outline the procedure to be followed.
- (iii) The Lead Officer will outline the matter in hand.
- (iv) The applicant or representative will present his/her case, with or without witnesses, and be questioned by members or any objectors/persons making representations present.
- (v) Any objectors/persons making representations may then present their objections/representation, with or without witnesses, and be questioned by members or the applicant/s or their representative.
- (vi) The objectors/persons making representations may make a final statement (without introducing new issues).
- (vii) Finally, the applicant has the right to make a final statement (without introducing new issues).
- (viii) All evidence/disclosures are to be made in the presence of all persons, unless someone voluntarily excuses themselves from the proceedings.
- (ix) Committee members shall restrict themselves to questions and not discussion or comment.
- (x) The applicant, objectors/persons making representations shall be allowed to ask officers questions of a technical/factual nature at any time during the proceedings.
- (xi) An adjournment should be granted where to do otherwise would deny a fair hearing.
- (xii) The Committee may resolve to decide upon the application in private session, however, if it becomes necessary to recall anyone for additional information, everyone shall be invited to return to the Hearing.
- (xiii) The decision shall be given in the presence of all parties that wish to be present and confirmed in writing as soon as possible thereafter. If legal advice is given to members this advice will be repeated in summary form.

Report:

Application for a Grant of a Street Trading Consent

1. On the 3rd October 2022 the Licensing Department received an application for a Street Trading Consent from Christopher Davies of El Cafecito Ltd, to trade at The Loughton Club, 8 Station Road, Loughton, Essex, IG10 4NX. A copy of the application is attached to this report.

The applicant seeks to sell hot and cold drinks, pastries, baked goods and snacks

Monday to Friday 07:00 – 16:00, Saturday 09:00 – 15:00, and Sunday 10:00 – 15:00

Consultation

- 2. There is no requirement in the Local Government Miscellaneous Provisions Act 1982 Act to carry out any consultation, but the Licensing Authority notified Essex Police, Essex Fire and Rescue Service, Environmental Health, Community Resilience, Essex County Council Highways, Loughton Town Council and the ward councillors.
- 3. A public notice was also placed at the site. A copy of this is attached to the report.
- **4.** The authority has received one (1) representations of objection to this application from Loughton Town Council.

Additional Information

- 5. It is worthy for the sub-committee to note that a Street Trading Consent at the same location was previously granted. This Consent permitted the sale of hot food and drinks; Monday to Saturday 12:00 21:00; and Sunday 12:00 20:00. This trader sought not to renew ,and the consent expired on 5th April 2022.. This trader was subject to one complaint relating to customers loitering and obstructing the public footpath this was early into their grant of the consent. Following intervention by the Licensing Department this was addressed and rectified. No further complaints were received.
- **6.** This item was originally listed for 6th December 2022; however as no party attended to represent of the application; the committee resolved to adjourn the matter to a later date so the applicant can attend.

Conditions

- **7.** The sub-committee may attach conditions to a street trading consent as it considers reasonably necessary. These can include conditions to prevent
 - (a) obstruction of the street or danger to persons using it; or
 - (b) nuisance or annoyance (whether to persons using the street or otherwise).
- 8. The Consent can include permission to trade -
 - (a) from a stationary van, cart, barrow or other vehicle; or
 - (b) from a portable stall.
- 9. The sub-committee may decide that the Consent is subject to conditions -
 - (a) as to where the holder of the street trading consent may trade by virtue of the permission; and
 - (b) as to the times between which or periods for which he may so trade.
- **10.** Unless the sub-committee decides otherwise the Authority's standard conditions will apply to this consent. These are:

Standard Consent Conditions:

- 1. This Consent is valid from **FROM** to **TO** and no right to its renewal by the Council can be assumed or is implied.
- 2. The Consent Holder will at all times comply with the law. Particular attention should be paid to the requirements of the Health and Safety at Work Act 1974 The Food Safety (General Food Hygiene) Regulations 1995 and the Food Safety Act 1990.
- 3. The Consent Holder will not cause any nuisance.
- 4. No recorded or amplified music or radio will be played by the Consent Holder or any employee at the stall to the annoyance of any member of the public, local resident or occupier of nearby premises, except in the case of ice-cream vans who may use amplified chimes during permitted hours.
- 5. No water, rubbish or waste material will be discharged or deposited on the highway or any adjacent property or into any surface water inspection chamber or qully.
- 6. The stall will be kept in a clean, safe and well-maintained condition, to the satisfaction of the Council and its authorised Officers.
- 7. The Consent Holder will provide and maintain, at his own expense, adequate refuse receptacles for litter and waste and its disposal.
- 8. A notice stating the name of the Consent Holder and an address for complaints, will be displayed in a conspicuous position on the stall at all times when trading is being carried on at the stall.
- 9. If the Consent Holder or any employee is requested to move the stall by an authorised Council Officer or a Police Officer, he/she will immediately comply with that request.
- 10. The Consent Holder will ensure that persons with a disability people can be served at the stall.
- 11. Failure to comply with these conditions will put the Consent Holder at risk of having the Consent revoked and/or of prosecution.
- 12. The Consent Holder will take out and maintain at all times third party insurance cover with a minimum liability of at £1,000,000.
- 13. The Consent Holder will not place or allow to be placed; on the street or in a public place; any furniture or equipment other than as permitted by the Consent and he/she must maintain the same in a clean and tidy condition and ensure they are not placed so as to obstruct the entrance or exit from any premises.

- 14. No goods or services other than those authorised by this consent will be carried out at the stall.
- 15. Litter and trade waste arising from the activities of the Consent Holder in and around the stall, will be removed from the site on a daily basis and disposed of in an approved manner
- 16. The Consent Holder will ensure adequate provision for pest control.
- 17. It is the responsibility of the Consent Holder to clarify that any vehicle used under the terms of the consent for the sale of goods has a current MOT and valid motor insurance which must include business use.
- 18. The Consent Holder is responsible for ensuring that all vehicles associated with the Street Trading Consent are parked so as not to cause an obstruction of the highway.
- 19. (Ice cream vendors) Vans may not be parked in any one location for more than 20 minutes and must not visit the same location more than twice a day.

THE CONSENT DOES NOT:

- 1. Permit trading outside the terms of Consent.
- 2. Indicate that planning permission is not required.
- 3. Indicate that the unit is exempt from business rates.
- 4. Override parking restrictions or any other traffic regulations.
- 5. Imply approval from the Highway Authority or any other person or Authority.
- **11.** The street trading consent may be granted for a period not exceeding 12 months.

Appeal

12. The Act provides for no appeal against refusals although decisions have been challenged in the Courts by way of judicial review on the ground that the decision was not properly taken or that there was some procedural irregularity or breach of the rules of natural justice.

Variation of Premises Licence, 'Bonhomie', 14 Forest Drive, Theydon Bois CM16 7EY

The Parish Council has considered the application for a Variation of Premises Licence at Bonhomie (formerly Belgique), 14 Forest Drive, Theydon Bois CM16 7EY, and has the following concerns and objections.

Situated in the centre of a small parade of shops in Forest Drive, Theydon Bois, 'Bonhomie' is a café selling drinks, pastries and cakes, and brunch/deli-style hot and cold food. The business has the informal atmosphere of a café and is popular with families. The Parish Council has learned, anecdotally, that the intention is for this establishment to operate as a wine bar in the evenings.

The current Premises Licence for Bonhomie has opening times at 08:00 until 18:30 hours Monday to Sunday. The Variation of Premises Licence application seeks to extend opening times from 08:00 until 22:00 hours Monday to Sunday, and also to extend by the same hours the Sale by Retail of Alcohol, the Provision of Late Night Refreshment, and the Provision of Recorded Music – all to 22:00 hours.

The two storey flats above Bonhomie are in residential occupancy and the locality enjoys a quiet ambience both during the daytime and in the evening. Our main concerns and objections relate to the prevention of public nuisance and protecting the amenity of

residents, possible crime and disorder, excessive drinking, and the protection of children from harm. If this Variation of Premises Licence application was to be granted, Bonhomie would be the only establishment on that side of the road to remain open after 6pm. We have, incidentally, noted that the current opening hours of this business appear to be Monday to Saturday 07:30 - 16:30, Sunday - Closed.

The café is currently licensed to serve alcohol from 08:00 to 18:00 hours. There are two dine-in restaurants on the opposite side of Forest Drive: one of these is licensed to open and serve alcohol from 11:00 to 22.30 (II Bacio restaurant at 19B Forest Drive — to 23.00 Friday and Saturday); the other restaurant is licensed to open and serve alcohol from 12:00 to 23:00 (formerly Kuzine / Mazaca restaurant at 13 Forest Drive, premises are currently closed).

In the interests of the four licensing objectives, including the prevention of public nuisance, the Parish Council objected to Bonhomie's Variation of Premises Licence Application in 2018 to serve alcohol from 08:00 hours. The rationale for that application to serve alcohol so early in the day was, it is understood, to enable Bonhomie to offer a special birthday breakfast (with alcohol). Because the café is currently licenced to operate only during the daytime, the ability to serve alcohol from 08:00 has thankfully not noticeably changed the relaxed café vibe. Coffee, hot chocolate and other non-alcoholic drinks still appear to be the main order of the day.

However, to extend the hours of operating into the late evening – to 22:00 – would change this establishment from a café to a bar. The application is seeking to serve drinks and food both inside the premises, and outside the premises on an outdoor seating area. The disturbance to residents of the flats above, and also to residents of the flats located above premises on the opposite side of the road, would be unacceptable. The whole feel of this predominantly quiet neighbourhood would change.

There have been issues in the past whereby customers of the II Bacio restaurant at 19B Forest Drive caused a public nuisance through drinking on the forecourt area immediately outside that restaurant. Following a hearing, EFDC Licensing imposed strict conditions on the II Bacio premises licence whereby no food or drinks can be served outside the restaurant after 16:00 hours, and any doors to the restaurant must remain closed at all times. Smoking immediately outside the restaurant is restricted to 5 people at any time and must be supervised by a member of staff.

The Parish Council is strongly of the view that Bonhomie's Variation of Existing Premises Licence must be refused – for the sake of maintaining public safety, the protection of children, avoiding crime and disorder, and avoiding public nuisance. Noise nuisance in the evening caused by music and customers inside Bonhomie would inevitably reverberate

around several of the residential flats above. Equally, customers eating and drinking outside during the evening, and arriving and leaving by car, would cause a serious disruption to all nearby residents – including those living further along Forest Drive and in Buxton Road.

Other restaurants in Forest Drive do not serve food and drink outside during the evening (the restaurant at 13 Forest Drive does not serve food and drink outside at all). For Bonhomie to do so would be an anomaly and set an extremely unwelcome precedent. It would negatively change the pleasant and predominantly tranquil atmosphere of the village's parade of shops — and the peaceful environment that is returned to its residents in the evening. Lighting of the premises into the evening is also a public safety concern and is in conflict with the Theydon Bois Dark Skies Policy.

The 'Prevention of Public Nuisance' clauses annexed to the current Premises Licence for Bonhomie mandate that: the business must avoid causing disturbance to nearby residents; delivery of goods are carried out at such a time as to prevent nuisance and disturbance to nearby residents; staff who arrive early or depart late when the business is not open for trading must conduct themselves in such a manner to avoid causing disturbance to nearby residents.

If the business was to be open 7 days a week from 08:00 in the morning to 22:00 at night, serving alcohol and playing recorded music, as this application seeks to do, it would be impossible to not cause disturbance to nearby residents, nor to avoid creating a negative impact on the amenity of residents. This quiet location is clearly not suitable for the proposed evening operation, which does not, in the Parish Council's view, have regard to the proximity of residential development. The Parish Council requests that Epping Forest District Council refuses this Variation of Premises Licence application.

One of my officers had a look at the planning history of this site and it appears that planning consent ref: EPF/0190/09, which was the proposal for the continuance of use of premises as mixed use (Class A1 shops and Class A3 café), contained the following condition:

"The use hereby permitted shall not be open to customers/members of the public outside the hours of 8.00am to 6.00pm Monday to Saturday, 8.00am to 3.00pm on Sundays and shall remain closed on public holidays."

There appear to be no applications since that suggest any change to this, so the applicants may need to be informed that planning consent is likely going to be required for the change in their opening hours.

- Amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises
- Recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500

Mandatory Conditions All Premises Licence authorising supply of alcohol

The licence is granted subject to the Mandatory conditions for sale of alcohol as set out in the Licensing Act 2003 as amended by the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 and Order 2014.

- 1. No supply of alcohol may be made under the Premises Licence -
 - (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
 - (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
 - (a) a holographic mark or
 - (b) an ultraviolet feature.
- 6. The responsible person shall ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula -

$$P = D + (DxV)$$

Where -

- (i) P is the permitted price
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b)
 - of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

If the Premises Licence allows Exhibition of Films

- 1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.

3.Where

- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4.In this section "children" means any person aged under 18; and "film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984(c39) (authority to determine suitability of video works for classification).

If the Premises Licence has conditions in respect of Door Supervision except theatres, cinemas, bingo halls and casinos

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:
 - (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
 - (b) be entitled to carry out that activity by virtue of section 4 of the Act.
- 2.But nothing in subsection (1) requires such a condition to be imposed:
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licences authorising plays or films); or
 - (b) in respect of premises in relation to:
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.
- 3. For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that schedule.

Annex 2 – Conditions consistent with the Operating Schedule:

General

To promote the four Licensing Objectives, Management will have strong controls and effective training of all staff to ensure awareness of the premises licence and the requirements to meet the four licensing objectives with particular attention to:

- a) no selling of alcohol to underage people
- b) no drunk and disorderly behaviour on the premises area
- c) vigilance in preventing the use and sale of illegal drugs at the retail area
- d) no violent and anti-social behaviour
- e) no any harm to children
- The Designated Premises Supervisor will have day-to-day control of the premises and will provide good training for staff on the Licensing Act (Training Record), to make or authorise each sale
- A Challenge 25 scheme will be operated to prevent the supply of alcohol to under-age drinkers.
- Alcohol will be stored in a lockable cabinet to ensure that it is safe and secure at all times

The DPS will operate the business with a purpose of promoting the four licensing objectives. This will be supported through the operating schedules and other measures (including staff training and qualifications, policies, and strategic partnerships with other agencies).

The Prevention of Crime and Disorder.

- 1. The premises shall have installed and maintain a closed circuit television surveillance (CCTV) system which at all times complies with the below requirements:
 - i. CCTV will be provided in the form a recordable system, capable of providing pictures of evidential quality in all lighting conditions particularly facial recognition;
 - ii. CCTV cameras shall cover all entrances and exits and the areas where alcohol sales take place;
 - iii. Equipment must be maintained in good working order, be correctly time and date stamped, recordings must be kept in good working order and kept for a minimum period of 31 days;
 - iv. Upon the reasonable request of the police or licensing authority staff, within 48 hours viewable copies of recordings will be provided.
- 2. An incident log shall be kept at the premises, and made immediately available to police or licensing authority staff upon request. The log must be kept as a bound document with individually numbered pages and be retained for a period of at least 6 months after the last incident recorded. The log must be completed as soon as is possible and within any case within 4 hours of the occurrence and shall record the following:
 - a) all crimes reported to the venue
 - b) all ejections of patrons
 - c) any complaints received concerning crime and disorder
 - d) any incidents of disorder
 - e) all seizures of drugs or offensive weapons
 - f) any faults in a CCTV system, searching equipment or scanning equipment mandated as a condition of the licence

Public Safety

- 1. A clear and legible notice to be displayed outside the premises indicating the normal hours of operation during which licensable activities are permitted.
- 2. Clear and conspicuous notices must be displayed warning of potential criminal activity, such as theft, that may target customers.
- Alcohol must not be sold to intoxicated customers.
- 4. Custom must not be sought by means of personal solicitation outside or in the vicinity of the licensed premises.
- 5. Staff will be trained in asking customers to use the premises in an orderly and respectful manner and prevent drinking alcohol at the retail counter area
- 6. Alcohol will only be served ancillary to a meal.
- 7. A refusal log book must be kept at the premises.
- 8. A Health & Safety Manual must be kept at the premises.

Prevention of Public nuisance

- 1. Prominent, clear and legible notices must be displayed at the exit to the premises requesting customers to respect the needs of nearby residents and to leave the premises and the area quietly.
- Deliveries of goods necessary for the operation of the business must be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.
- Management will ensure that staff who arrive early morning or depart late afternoon (eg.
 for unpacking, pricing newly delivered goods) when the business is not open for trading,
 must conduct themselves in such a manner to avoid causing disturbance to nearby
 residents.
- Customers to be requested not to stand around loudly talking in the street outside the premises.
- 5. Customers must not be admitted to the premises outside of opening hours.
- 6. The movement of bins and rubbish outside the premises will be kept to a minimum and there will be no activity after 19:00.

7. Any lighting on or outside the premises must be positioned and screened in such a way so as to not cause a disturbance to nearby residents.

The Protection of children from harm

A Challenge 25 scheme shall be operated, whereby any person who appears to be under the age of 25 years of age is required to produce on request an item which meets the mandatory age verification requirement and is either a:

- Proof of age card bearing the PASS Hologram;
- Photocard driving licence;
- Passport; or
- Ministry of Defence Identity Card.
