Regulatory Committees

(a) Licensing Committee

Terms of Reference

(1) The full Committee shall comprise 15 Councillors appointed by the Council at its annual meeting, including a Chairman and Vice-Chairman.

(2) For the functions set out in Appendix 1, and the legislation listed in Appendices 2 and 3, a sub-committee consisting of no more than any three Councillors drawn from the members of the full Committee shall be formed. Any such sub-committee shall include, by rota, one of the six Licensing Sub-Committee Chairmen appointed at each Annual Council meeting.

(3) The Quorum for the Committee is set out in the Rules set out in Part 4 of this Constitution save that no business shall be transacted unless either the Chairman or Vice-Chairman of the Committee is present.

(4) The Committee and sub-committees shall have full authority to hear and determine licensing applications.

(5) The Committee and sub-committees shall be further empowered to determine appeals made against the decisions of the Service Director (Commercial and Regulatory Services) taken under delegated authority on licensing applications. (See Council delegation schedule for more details).

(6) The Committee shall at all times carry out its duties solely within the policy from time to time determined by the Council and shall conduct its proceedings in accordance with the requirements set out in Appendix 4 (Conduct of Business by the Licensing Committee and Sub-Committees).

(7) The Licensing Committee shall take no part in the production or revision of the statement of licensing policy made under Section 5 of the Licensing Act 2003, however, they may determine policy under the legislation listed in Appendices 2 and 3 to this Article.

(8) To be responsible for the consideration and approval of Designation Orders under Section 13 of the Criminal Justice and Police Act 2001 (Exercise of Controls over the consumption of alcohol in Public Places).

Appendix 4

PART A – CONDUCT OF BUSINESS BY LICENSING COMMITTEE AND SUB-COMMITTEES

All references to committee in this annex shall be taken to infer a reference to the associated subcommittees.

1. General Conduct

- 1.1 All hearings of the Licensing Committee under the Licensing Act 2003, are to be held in accordance with the Personal Licences, Hearings, Premises Licences and Club Premises Certificates, and Licensing Register Regulations, made under the Licensing Act 2003.
- 1.2 The Council's Constitution shall regulate the conduct of and debate at meetings.
- 1.3 In the case of hearings under the Licensing Act 2003, the Committee shall only consider those matters relevant to the licensing objectives as set out in the Licensing Act 2003 and the statement of licensing policy adopted by the Council.

2. Declarations of Interest

2.1 Members of the Committee are subject to the Council's Code of Conduct.

3. Participation in the Hearing

- 3.1 Debate shall be restricted to members of the Licensing Committee. Where a local ward member, not being a member of the Committee, wishes to participate in the hearing, they may do so only with the permission of the Chairman and their participation shall be subject to the same rules as are applied to any other witnesses to the application.
- 3.2 In hearings other than those under the Licensing Act 2003, where a ward member is a member of the Committee, and wishes to object to the application, the member shall give 14 days' notice of their intention, and shall play no part in the decision-making process of the Committee. In hearings under the Licensing Act 2003, those named as responsible authorities and interested parties in the Act may only make representations within the time limits set out in the relevant statutory provisions.
- 3.3 All persons participating in the hearing shall be made aware of the limitations or scope of statements that will be acceptable and, in particular, that statements should be factual or a fair statement on a matter of public interest.
- 3.4 In the case of any hearing pursuant to the summary review procedure under the Violent Crime Reduction Act 2006, the membership of any Subcommittee adjudicating on such a review shall comprise any three members drawn from the Licensing Committee subject to the proviso that no member should serve more than one hearing.

4. Attendance of the Public

4.1 The Council's Constitution and relevant statutory provisions relating to the admission or exclusion of the public shall apply to all meetings of the Licensing Committee.

5. Natural Justice

5.1 There are two elements to natural justice:

(a) Fairness

- (i) All persons affected by the decision or in the case of matters associated with the Licensing Act 2003, those named as responsible authorities and interested parties in the Act, will be allowed a hearing before a decision is made.
- (ii) Only objectors who can show clearly that they are affected by a decision shall be afforded the right to be heard or, in the case of hearings under the Licensing Act 2003, only those named in the Act as responsible authorities or interested parties.
- (iii) All information shall be made available, where possible in advance, to the applicant and the Committee.
- (iv) All members of the Committee shall be present throughout the hearing of a particular application. Where a member arrives late or leaves during a hearing of a particular application, that member shall play no part in the decision-making process. Where an application is adjourned it shall be continued by the same members only, and no others.
- (v) The Committee shall have discretion in respect of 'late' objections. Such objections shall be clearly marked on the agenda as such and the Committee shall decide on their acceptability. The applicant shall be advised of any late objections. In the case of representations made in relation to the Licensing Act 2003 applications, these shall only be accepted in accordance with the relevant statutory provisions.

(b) Prevention of Bias

- (i) The rules on the declarations of interest shall be firmly applied.
- (ii) If the Committee moves into private session to consider its decision, it shall be accompanied only by its advising officers, none of whom shall have taken a substantive part in the hearing, and shall play no substantive part in the decisionmaking process.

6. General Procedures for Hearings

- 6.1 The following procedural requirements shall be followed at all times:
 - (a) There shall be no recommendation from officers on the agenda;
 - (b) The Committee shall be supplied with copies of all relevant documentation and the process and order of procedure shall be as follows:

- (i) The Chairman will open the meeting and introduce persons as appropriate asking applicants and representatives to identify themselves.
- (ii) The Chairman will outline the procedure to be followed.
- (iii) The Lead Officer will outline the matter in hand.
- (iv) The applicant or representative will present his/her case, with or without witnesses, and be questioned by members or any objectors/persons making representations present.
- (v) Any objectors/persons making representations may then present their objections/representation, with or without witnesses, and be questioned by members or the applicant/s or their representative.
- (vi) The objectors/persons making representations may make a final statement (without introducing new issues).
- (vii) Finally, the applicant has the right to make a final statement (without introducing new issues).
- (viii) All evidence/disclosures are to be made in the presence of all persons, unless someone voluntarily excuses themselves from the proceedings.
- (ix) Committee members shall restrict themselves to questions and not discussion or comment.
- (x) The applicant, objectors/persons making representations shall be allowed to ask officers questions of a technical/factual nature at any time during the proceedings.
- (xi) An adjournment should be granted where to do otherwise would deny a fair hearing.
- (xii) The Committee may resolve to decide upon the application in private session, however, if it becomes necessary to recall anyone for additional information, everyone shall be invited to return to the Hearing.
- (xiii) The decision shall be given in the presence of all parties that wish to be present and confirmed in writing as soon as possible thereafter. If legal advice is given to members this advice will be repeated in summary form.

Report:

Application

ARCHPL Ltd. on behalf of Hasan Kartal have applied for the grant of a new Premises Licence in respect of The Palace Banqueting Suite, Town Mead, Brooker Road, Waltham Abbey, Essex, EN9 1JH.

The application was received on the 3rd April 2023. Originally the application sought the following licensable activities and hours as detailed, in the application:

- Provision of live & recorded music, provision of performances of dance* Sunday to Friday 23:00 to 00:30 Saturday 23:00 to 04:00
- Supply of alcohol Sunday to Friday 11:00 to 00:30 Saturday 11:00 to 04:00
- Opening hours Sunday to Friday 11:00 to 01:00 Saturday 11:00 to 04:30

However, during the consultation period, the applicant has confirmed that they wish to amend the application by reducing the timings for the licensable activities on Saturdays and to agree additional conditions recommended by Essex Police and the councils Community Resilience Team.

Accordingly, the amended application now being considered by the Licensing Sub-Committee is as follows:

- Provision of live & recorded music, provision of performances of dance* Sunday to Monday 23:00 to 00:30
- Supply of alcohol Sunday to Monday 11:00 to 00:30
- **Opening hours** Sunday to Monday 11:00 to 00:30

* As per the Live Music Act no licence is required for:

- Amplified live or recorded music in licensed premises where alcohol is supplied, for audiences up to 500 between the hours of 8am and 11pm.
- Unamplified live music anywhere and with no audience limit between the hours of 8am and 11pm.
- Performance of dance anywhere for audiences up to 500 between the hours of 8am and 11pm.

Responsible Authorities and other persons who made a representation were notified of the reduced hours now being applied for.

Licensing Act 2003

When considering an application for a licence the licensing authority must have regard to steps that are appropriate to promote of the licensing objectives.

These are—

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

The Operating Schedule sets out conditions which will be attached to the licence if this application is granted.

Consultation

The consultation period ran from the 4th April 2023 to the 1st May 2023.

All Responsible Authorities received a copy of the application and are aware of the amended hours.

The application was advertised at the premises and in the local newspaper. All residents and businesses within 150 metre radius were also informed by letter.

The authority has received: 29 representations from local residents. The representations relate to all of the licensing objectives and are attached to this report.

During the consultation period the applicant has agreed conditions with Essex Police and the councils Community Resilience Team, the agreed conditions can be found attached to the report.

Essex County Fire & Rescue Service audited the application and based on the information submitted, do not anticipate any additional risk to the public. This is attached also.

Guidance Issued by the Secretary of State

The Licensing Act 2003 provides that the licensing authority must 'have regard to guidance issued by the Secretary of State under section 182.

Sections 2.15 to 2.21 of the Guidance are relevant to this application.

Options

In determining this application, the Sub-Committee may take any of the following steps as it considers necessary for the promotion of the licensing objectives, namely:

(a) to grant the licence as applied for subject to

- the conditions mentioned in the Operating Schedule modified as the Subcommittee considers necessary for the promotion of the licensing objectives, and
- the mandatory conditions specified in the Licensing Act 2003, or Page 12

- (b) to exclude from the scope of the licence any licensable activities to which the application relates, or
- (c) refuse to specify a person as the premise's supervisor, or
- (d) reject the application

Determination

The Sub-committee is asked to determine the application having regard to

- (a) the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

Appeal

If any party is aggrieved with the decision, they can appeal to Magistrates court. The appeal period is 21 days from notification of the decision.

- 10. Have the recording device located in a secure area or locked cabinet.
- 11. Have a monitor to review images and recorded picture quality.
- 12. Be regularly maintained to ensure continuous quality of image capture and retention.
- 13. Have signage displayed in the customer area to advise that CCTV is in operation.
- 14. Digital images must be kept for 31 days.
- 15. Police will have access to images at any reasonable time.

16. The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. 

I live at Audley Gardens, Waltham Abbey EN9 1RT, which backs directly onto Town Mead Park, and specifically the building which has been leased to the Palace Banqueting Suite.

I object to the Planning Application on the following grounds:

1. That the opening hours up to 1.00am seven days a week will impact on residents, in that there will be a lot of noise from up to 400 guests who choose to drink/smoke outside the building, especially during warmer weather.

2. Residents may have their windows open on hot nights, and those backing directly onto the Park will be most affected by the noise.

3. The noise created once the venue closes and up to 400 people are driving away from the carpark (which backs directly onto Audley Gardens).

4. The noise created by cabs arriving to pick up guests, or those guests leaving on foot, who may decide to leave the park via the Orchard Gardens exit, creating more noise and disturbance, especially if they are drunk. If events are held 7 nights a week, there is great potential for increased vandalism and anti-social/criminal activity.


5. The car park next to the building is for the use of all visitors to the park. It is not exclusively for the use of the applicant, despite the video on his website which suggests the opposite.

It is a relatively small car park, and we are concerned that guests to the venue decide to park in nearby residential roads, which are already overcrowded. 6. Vandalism is already a problem in the park, and late opening hours potentially will encourage more vandalism.

 The street lighting is very poor, and it is already unsafe for residents walking home. Groups of people, possibly drunk, leaving the venue and wandering the streets will add to the risk, especially once the street lights are turned off.
 A 15-year lease is a very long time to commit to one business, which seems to offer nothing to benefit local residents, but a lot of money (£90k a year) for the council. Will this money be used for the benefit of the local community? What breaks will be incorporated into the lease and what will activate a break?

I am a resident of Mead Court, Waltham Abbey, EN9 1RG and understand that Mr Hasan Kartal has applied for a license for The Palace Banqueting Suite in Town Mead which would include music until 00:30 Sunday to Friday extended to 04:00 on Saturdays as well as the supply of alcohol to the same times.

Please accept this email as a formal objection to this license.

Our property is located around 200 yards from the property, when Town Mead was run by the council if they hired the venue out privately the sound would travel across open fields, if there was karaoke you could sing along to the songs, it was very disruptive for our children but this generally ended at 23.00 and whilst it was frustrating it was acceptable as it didn't happen often. On those occasions you would have people leaving the venue on foot via one of the 2 footpaths, one which leads out to Orchard Gardens and the other leading out to Brooker Road, the exit to Orchard Gardens was the one that affected us, being 75 yards from our garden. Invariably there were arguments, smashed bottles and generally just not a nice thing to listen to at night.

As a family we feel that issuing this license will cause increased crime and disorder in the area, there are already a number of occasions where police have been called out to Town Mead for anti social behaviour; as there is only one road in via an industrial area it is quite an isolated site. Town Mead is enjoyed by families by day with excellent park and sporting facilities which I understand are being developed further, however, anti social behaviour in the evening is sometimes a problem and this will be exacerbated by a late night drinking venue in the area.

The site is opposite a well used childrens park, if entertainment is still going on until the early hours of the morning children will be going to the park and getting ready to play football a few hours later. There will be bottles, empty gas cannisters and cigarette butts laid out in front of the site. The issue of such a license would have such a counter productive effect on trying to establish a family friendly environment in Town Mead.

As mentioned above the noise pollution from that site will be significant, I can assure you that if we can hear the lyrics to music in Mead Court from a mobile DJ, the problem will be the same for Orchard Gardens, Town Mead Road, Grange Court and Abbey Court and even worse for the poor residents of Audley Gardens. We can expect late night fireworks to accompany the noise from music. Values of properties in the area will be greatly diminished. Police will be constantly called out to disturbances of the peace.

Although Mr Kartal's company Saray Events Ltd have yet to file trading accounts one review of the company on Google reads:

Why is this place allowed to be open. They operate out of business hours cause loud noises disturbing the residents. They almost set the entire block on Fire today by doing big fireworks right next to a tower block. They started a fire and failed to contain it. Fire brigade had to assist.

Idiots. Why are you open? You will be receiving a barrage of complaints shortly as the residents have been gathering evidence of all of this anti social behaviour.

Idiots. The amount of sleep I have lost because of this place.

Another review complains about parking issues, its therefore likely that the Town Mead Car Park can't cope with the large number of attendees, which will mean parking on local roads and cars being left overnight to be collected the next day. It is therefore not out of the question to assume that all the potential issues I feel this will cause is the very reason why the company are looking for a new venue. Please do not allow these issues to come to our area.

There must be far better uses of this facility for the community, however, if this must be an entertainment venue I implore with you, please do not issue this license for drinking and music past 23:00 if at all. This site is not as isolated as you may think and I therefore don't feel it is suitable for this sort of activity. This kind of activity should be conducted away from residents and hopefully that will be the case in this instance.

would serve patrons during the morning / afternoon for football, baseball and the local community with drinks, snacks and hot food and toilet facilities then only Fridays & Saturdays evenings would be hired out, usually to the local community for birthday parties etc and would stop serving alcohol at 11pm so a majority of the patrons would be gone by midnight (very respectful time for surrounding residents)

The new times would not serve the local public in the mornings at all, alienating the locals sports going on in the mornings.

This venue is being advertised as a banquet hall for weddings, birthdays and CONCERTS! Please see attached photo taken from a member of his family. So presumably they will not want the general public entering the venue for a pint and a toilet break when getting ready for a wedding? Patrons leaving after 01.00 and 04.30 would make a big impact on local residents as Satnav takes you to Orchard Gardens and NOT town mead park, thus creating cab noise and parking issues due to the public carpark being limited also with increased noise levels At unacceptable times in the morning.

Exits on foot are via 2 residential areas to get to the town centre.

Second Objection - supply of Alcohol extension Sun - Fri 11.00 - 00.30 Sat - 11.00 - 04.00

If the extension time changes are put into place and a license given. patrons would be able to consume alcohol for 13hrs a day 6 days a week and 17 hrs on a Saturday if desired. increasing the number of alcoholic incidence occurring and noise from intoxicated individuals leaving and heading away from the venue, TWO OUT OF THREE EXITS ARE VIA RESIDENTIAL AREAS.

It has come to my attention that an application has been made by a Mr Hasan Kartal for a provision of live and recorded music, provision of performances of dance and supply of alcohol between the hours of <u>11am-12:30am Sunday-Friday</u> and <u>11am-4am Saturday</u>. I have found this out via a resident from a neighbouring road who shared this information. when the dugouts were destroyed. All of these incidents have been reported to the police by myself or neighbours yet the antisocial behaviour has not stopped, if anything it has increased. Our concern is that additional late night drinking at this venue will add to the disturbances on Town Mead and further unsettle our community, disruption from the noise of those attending the venue at these ridiculous times of night will disturb the sleep of our family and add additional stress which could be avoided.

In addition, I am concerned about the potential littering and vandalism that could occur from those attending the venue, under the influence of alcohol. The venue is directly opposite a children's playground and the football pitches. Do you really think it's acceptable to be promoting drinking and partying opposite a children's recreational facility? And what about the potential for littering; broken glass, cigarettes and worse. If the police are unable to control the current levels of antisocial behaviour on Town Mead, how will they cope with this additional stress on their resources?

I trust that you will heed my concerns and oppose this application.

I am writing to you in regards to objecting heavily to object to Mr Hasan Kartal's provision of live music and alcohol serving times at The Palace banqueting, Town Mead Park. I believe you will receive many objections but please see below my personal views for the harsh objection.

To start the noise/music that will be emitted from the venue will cause immediate disturbance to the residents who don't like to be awake until 4am, as my house backs directly onto the park I can assure you from previous experience that the noise emits very far and when the venue previously closed at 12am the noise and disruption would carry on until the early hours of the morning on many occasions meaning the police were made aware.

Secondly, the increase of anti-social behaviour at the venue and surrounding areas is a worry as a resident. Serving alcohol until the early hours of the morning will only increase the risk to us residents for the customers leaving the venue to get home, this in the past has included customers/collectors of the customers urinating at the surroundings of the venue, fights/arguments between customers breaking out at the venue and continuing throughout surrounding areas, bottles, broken glass and general rubbish left at the venue and surrounding areas which may I remind you is a public place where young kids and animals are constantly using as a walk way which will occur danger, to name only a few antisocial behaviours the hours purposed will occur.

To remind you our street lighting is only lit until midnight therefore again is putting residents in danger with customers leaving the premises.

To add to this, as a small town where as I am aware no pub/venue is allowed to open or serve alcohol past the early hours of the morning as soon as these venues close all of the customers from these venues will start to make their way to The Palace causing again disruption to the local residents and surrounding areas. Not only this but the address for Town Mead car park leads you to Orchard Gardens/Audley Gardens therefore I ask the question, where do you think intoxicated customers/Uber drivers will end up located?

The vandalism, safety concerns and general worry us residents is already at risk from Town Mead park and this is without adding a socially loud alcohol serving venue to the agenda, as a resident that backs onto the park the proposal is causing me a lot of stress and I know my fellow residents feel the same to which is why we will all be writing to highlight our concerns and object fully the proposal.




