SUBSTITUTE MEMBERS (COUNCIL MINUTES 39 - 23.7.02)

2. DECLARATION OF INTEREST

Pursuant to the Council's Code of Member Conduct, Councillor S Murray referred to the item on the Future Management of the Roding Valley Meadows Local Nature Reserve. He declared a general personal but non-prejudicial interest in the item by virtue of being the Council's representative on their Management Board and the nature reserve having a partnership with Roding Valley High School.

Pursuant to the Council's Code of Member Conduct, Councillor Mrs Grigg referred to the item on the Future Management of the Roding Valley Meadows Local Nature Reserve. She declared a general personal but non-prejudicial interest in the item by virtue of being the Council's representative on their Management Board.

3. SCOPE OF THE REVIEWS

The panel noted that the review of the future management of the Roding Valley Meadows Local Nature Reserve and the future management of the Waltham Abbey Sports Centre were time limited and would have to be tackled first.

The Essex Wildlife Trust currently manages the Roding Valley Meadows Local Nature Reserve, but this agreement runs out in March 2007, after 21 years. Because of this, it is now necessary to undertake a review of the service.

Derek Macnab indicated that John Hall, the Chief Executive of the Essex Wildlife Trust would be happy to help the Panel in their deliberations, and that the panel should also seek the views of the Grange Farm Trust, Management Committee

Liaison Committee and the Pony Riding for the Disabled Charity who use the nature reserve.

Councillor Murray told the Panel that this is a very sensitive issue in the Buckhurst Hill, Chigwell and Loughton part of the district and provision should be made to take the views of the local people on board either as written evidence or orally.

The Waltham Abbey Sports Centre is shared with the King Harold Secondary School and is currently jointly managed with Essex County Council (the Education Authority) and EFDC. This dual use agreement is due to come to an end in September 2007 and a review of the future management arrangements needs to be undertaken.

The Panel will need to speak to the staff of the sports centre, speak to the school and to the governors; efforts should be made to seek the views of the school children as they are potential users of the centre.

A visit to Waltham Abbey Sports Centre and Swimming Pool was arranged for the Panel on Tuesday 18 July 2006.

The panel then considered the two less-time sensitive items that needed reviewing, the Future Development of the Arts in Epping Forest and the District Council's Role and Involvement in Outdoor and Community Events.

A full presentation on the development of arts in Epping Forest will be given to the Panel on 31 July 2006. The panel is asked to undertake an examination of the arts in terms of local provision and impact on the local community. To enable it to do this the panel should consult with Theatre Resource, Voluntary Services, Members of the Local Strategic Partnership, Epping Forest College, Harlow Playhouse and if possible, Residential Care Homes and Sheltered Housing officers involved in arts projects in the district. Considering the large amount of research that needed to be undertaken it was thought that the panel could split into groups (or individually) and carry out research trips, as well as visiting some places as a Panel.

The District Council has a need to address and assess it's involvement and role in outdoor and community events. Taking into account the increasingly complex legislative framework, which is stopping people from putting on events. North Weald Airfield is host to most of the Council's major outdoor events and has the potential to develop long term into a recognised regional entertainment venue.

4. TERMS OF REFERENCE

The panel agreed the terms of reference attached to these minutes.

5. WORK PROGRAMME

Details of a work programme to be worked out over the next few meetings. A draft work programme is attached.

In order for the panel to make any recommendations that would affect budgets for any of the items that it is to consider, a preliminary report should be completed by 5 October 2006 that would put down a marker for the next budget round.

Visits are to be arranged on a mixture of evening and daytime visits.

TIME SCALE FOR FINAL REPORT

The Panel agreed that:

- The Roding Valley Nature Reserve and the Waltham Abbey Sports centre tasks should be finished by January 2007.
- The review of arts development and the role of the District's involvement in Outdoor and Community Events Tasks should be completed by February – March 2007.
