- 2. To find out what services are provided by the district council, Voluntary Action Epping Forest and if there are any difficulties in accessing these services; if there are any gaps; and are they adequately funded and advertised.
- 3. To confirm if the council complies with the December 2006 section of the Disabled Discrimination Act that states that public bodies must anticipate problems and encourage the involvement of disabled people in public life.
- 4. To make any recommendations that identified the need for extra spending by 18 September 2006 in order to meet the deadline for the budget fixing round for next year.
- 5. To find out about the specialist transport on offer, and about the Taxi Card System offered by other councils.
- 6. To investigate the use of bus passes and the relevance to the availability busses.
