#### 5. NEW CODE OF CONDUCT

#### **Recommendation:**

To receive a progress report on the adoption of the new Code by parish/town councils and completion of registrations of interests by district and parish/town councillors.

(Monitoring Officer) At the last meeting, the Committee noted that the District Council had adopted the new Code of Conduct, without alteration, on 28 June 2007.

The Committee requested that a progress report be submitted to this meeting on adoption of the new Code by parish /town councils and on completion of new registrations of interests by district and parish/town councillors.

Notification of adoption of a new Code has now been received from all 24 parish/town councils.

Within 28 days of adoption of a new Code all members are required to re-register their interests. All 58 district councillors have completed and returned new registration of interest forms. Forms have also been received from 18 parish/town councils. Clarification of the position of the remaining parish/town councils is being pursued.

#### 6. CODE OF CONDUCT - APPLICATIONS FOR DISPENSATION

#### Recommendation:

To note that following the last meeting of the Committee, no further applications for dispensation were received and a decision on the acceptance of tenders for the provision of bed and breakfast accommodation to house homeless persons has now been taken.

(Monitoring Officer) At the last meeting of the Committee, consideration was given to five applications from members of the District Council's Cabinet for dispensation to take part in a decision regarding the acceptance of tenders for the provision of bed and breakfast accommodation to house homeless persons.

The Committee agreed to hold a special meeting, if necessary, in order to consider possible applications from the remaining three members of the Cabinet No further applications were received and it became clear the Cabinet quorum had been lost. In order to resolve the issue the Cabinet delegated the decision to a Portfolio Holder who did not have a prejudicial interest to declare. As a result there is no need for this Committee to take any further action.

Paragraph 9 of the Council Procedure Rules contained in the Constitution require:

- (1) All business of the Council requiring to be transacted in the presence of the press and public to be completed by 10.00 p.m. at the latest.
- (2) At the time appointed under (1) above, the Chairman shall permit the completion of debate on any item still under consideration, and at his or her discretion, any other remaining business whereupon the Council shall proceed to exclude the public and press.
- (3) Any public business remaining to be dealt with shall be deferred until after the completion of the private part of the meeting, including items submitted for report rather than decision.

**Background Papers:** Paragraph 8 of the Access to Information Procedure Rules of the Constitution define background papers as being documents relating to the subject matter of the report which in the Proper Officer's opinion:

- (a) disclose any facts or matters on which the report or an important part of the report is based; and
- (b) have been relied on to a material extent in preparing the report does not include published works or those which disclose exempt or confidential information (as defined in Rule 10) and in respect of executive reports, the advice of any political advisor.

Inspection of background papers may be arranged by contacting the officer responsible for the item.
