#### **APPENDIX 5**

#### LICENSING COMMITTEE - TERMS OF REFERENCE

- (1) The full Committee shall comprise 15 Councillors appointed by the Council at its annual meeting, including a Chairman and Vice-Chairman.
- (2) For the functions set out in Annex 1, and the legislation listed in Annex 2, a Sub-Committee consisting of no more than any three Councillors drawn, in alphabetical order, from the members of the full Committee shall be formed. Any such Sub Committee shall include, by rota, one of the six Licensing Sub Committee Chairmen appointed at each Annual Council meeting.
  - (3) For the transaction of business at full Committee meetings, the quorum shall be a minimum of five Committee members save that no business shall be transacted unless either the Chairman or Vice-Chairman of the Committee is present.
  - (4) The Committee and Sub-Committees shall have full authority to hear and determine licensing applications.
  - (5) The Committee and Sub-Committees shall be further empowered to determine appeals made against the decisions of the Head of Environmental Services taken under delegated authority on licensing applications.
  - (6) The Committee shall at all times carry out its duties solely within the policy from time to time determined by the Council and shall conduct its proceedings in accordance with the requirements set out in Annex 3 (Conduct of Business by Licensing Committee and Sub-Committees).
  - (7) The Licensing Committee shall take no part in the production or revision of the statement of licensing policy made under Section 5 of the Licensing Act 2003, however, they may determine policy under the legislation listed in Annex 3.
  - (8) To be responsible for the consideration and approval of Designation Orders under Section 13 of the Criminal Justice and Police Act 2001 (Exercise of Controls over the consumption of alcohol in Public Places).

# PART A – CONDUCT OF BUSINESS BY LICENSING COMMITTEE AND SUB-COMMITTEES

All references to committee in this annex shall be taken to infer a reference to the associated sub-committees.

### 1. General Conduct

- 1.1 All hearings of the Licensing Committee under the Licensing Act 2003, are to be held in accordance with the Personal Licences, Hearings, Premises Licences and Club Premises Certificates, and Licensing Register Regulations, made under the Licensing Act 2003.
- 1.2 The Council's Constitution shall regulate the conduct of and debate at meetings.
- 1.3 In the case of hearings under the Licensing Act 2003, the Committee shall only consider those matters relevant to the licensing objectives as set out in the Licensing Act 2003 and the statement of licensing policy adopted by the Council.

### 2. Declarations of Interest

2.1 Members of the Committee are subject to the Council's Code of Conduct and to advice from the Standard Board for England, details of which will be provided to those members.

### 3. Participation in the Hearing

- 3.1 Debate shall be restricted to members of the Licensing Committee. Where a local ward member, not being a member of the Committee, wishes to participate in the hearing, they may do so only with the permission of the Chairman and their participation shall be subject to the same rules as are applied to any other witnesses to the application.
- 3.2 In hearings other than those under the Licensing Act 2003, where a ward member is a member of the Committee, and wishes to object to the application, the member shall give 14 days' notice of their intention, and shall play no part in the decision-making process of the Committee. In hearings under the Licensing Act 2003, those named as responsible authorities and interested parties in the Act may only make representations within the time limits set out in the relevant statutory provisions.
- 3.3 All persons participating in the hearing shall be made aware of the limitations or scope of statements that will be acceptable and, in particular, that statements should be factual or a fair statement on a matter of public interest.

3.4 In the case of any hearing pursuant to the summary review procedure under the Violent Crime Reduction Act 2006, the membership of any Sub-Committee adjudicating on such a review shall comprise any three members drawn from the Licensing Committee subject to the proviso that no member should serve more than one hearing.

#### 4. Attendance of the Public

4.1 The Council's Constitution and relevant statutory provisions relating to the admission or exclusion of the public shall apply to all meetings of the Licensing Committee.

### 5. Natural Justice

5.1 There are two elements to natural justice:

### (a) Fairness

- (i) All persons affected by the decision or in the case of matters associated with the Licensing Act 2003, those named as responsible authorities and interested parties in the Act, will be allowed a hearing before a decision is made.
- (ii) Only objectors who can show clearly that they are affected by a decision shall be afforded the right to be heard or, in the case of hearings under the Licensing Act 2003, only those named in the Act as responsible authorities or interested parties.
- (iii) All information shall be made available, where possible in advance, to the applicant and the Committee.
- (iv) All members of the Committee shall be present throughout the hearing of a particular application. Where a member arrives late or leaves during a hearing of a particular application, that member shall play no part in the decision-making process. Where an application is adjourned it shall be continued by the same members only, and no others.
- (v) The Committee shall have discretion in respect of 'late' objections. Such objections shall be clearly marked on the agenda as such and the Committee shall decide on their acceptability. The applicant shall be advised of any late objections. In the case of representations made in relation to the Licensing Act 2003 applications, these shall only be accepted in accordance with the relevant statutory provisions.

### (b) Prevention of Bias

- (i) The rules on the declarations of interest shall be firmly applied.
- (ii) If the Committee moves into private session to consider its decision, it shall be accompanied only by its advising officers, none of whom shall

have taken a substantive part in the hearing, and shall play no substantive part in the decision-making process.

### 6. General Procedures for Hearings

- 6.1 The following procedural requirements shall be followed at all times:
  - (a) There shall be no recommendation from officers on the agenda;
  - (b) The Committee shall be supplied with copies of all relevant documentation and the process and order of procedure shall be as follows:
    - (i) The Chairman will open the meeting and introduce persons as appropriate asking applicants and representatives to identify themselves.
    - (ii) The Chairman will outline the procedure to be followed.
    - (iii) The Lead Officer will outline the matter in hand.
    - (iv) The applicant or representative will present his/her case, with or without witnesses, and be questioned by members or any objectors/persons making representations present.
    - (v) Any objectors/persons making representations may then present their objections/representation, with or without witnesses, and be questioned by members or the applicant/s or their representative.
    - (vi) The objectors/persons making representations may make a final statement (without introducing new issues).
    - (vii) Finally, the applicant has the right to make a final statement (without introducing new issues).
    - (viii) All evidence/disclosures are to be made in the presence of all persons, unless someone voluntarily excuses themselves from the proceedings.
    - (ix) Committee members shall restrict themselves to questions and not discussion or comment.
    - (x) The applicant, objectors/persons making representations shall be allowed to ask officers questions of a technical/factual nature at any time during the proceedings.
    - (xi) An adjournment should be granted where to do otherwise would deny a fair hearing.
    - (xii) The Committee may resolve to decide upon the application in private session, however, if it becomes necessary to recall anyone

- for additional information, everyone shall be invited to return to the Hearing.
- (xiii) The decision shall be given in the presence of all parties that wish to be present and confirmed in writing as soon as possible thereafter. If legal advice is given to members this advice will be repeated in summary form.

### Report:

### **Application**

1. An application has been made by **Helen Kelly-Howe and Thomas Howe** trading as **Just at the Station Ltd**, for a New Premises licence for the above premises.

The authority received the application on **17**<sup>th</sup> **November 2015**. The application sets out the relevant licensing activities applied for and times requested: -

### **Proposed Operating Schedule.**

•	Live Music	Mon-Sun 12.00 – 01.00hrs
•	Recorded music	Mon-Sun 11.00 – 01.30hrs
•	Performance of dance	Mon-Sun 12.00 – 01.00hrs
•	Dancing	Mon-Sun 12.00 – 01.00hrs
•	Late night refreshment	Mon- Sun 23.00 - 01.30hrs
•	Supply of alcohol	Mon- Sun 11.00 - 01.00hrs

**2.** The Operating Schedule sets out conditions which will be attached to the licence if this application is granted.

### **Licensing Act 2003**

**3.** When considering an application for a licence the licensing authority must have regard to the promotion of the licensing objectives.

These are—

- (a) the prevention of crime and disorder;
- (b) public safety;
- (c) the prevention of public nuisance; and
- (d) the protection of children from harm.
- **4.** It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

### Consultation

- 5. The Responsible Authorities have received a copy of the application, it was properly advertised at the premises and in a local newspaper
- The Licensing authority have received **one** representation from the responsible authority – 'Essex Police', with in the attached letter dated 10th December 2015 Peter Jones requested 4 conditions to be added to the Licence. Through the consultation Period the applicant and Peter Jones, have agreed to remove condition 2 and Amend condition 3. Condition 1 & 2 will remain and be added to the proposed Licence.
- 7. The Licensing Unit received an acknowledgement from Essex County Fire & Rescue Service, Environmental Health and no objections from Essex County Council Child protection.
- 8. The Licensing unit have received **11** representations from interested parties.
- 9. The representations relate to. The Prevention of Crime and Disorder, Public Safety & Public Nuisance

### **Guidance Issued by the Secretary of State**

- 10. The Licensing Act 2003 provides that the licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182.
- Crime and Disorder 2.1 2.5, Public Safety 2.6 2.13 and Public Nuisance 2.14 2.30 of the Guidance are relevant to this application

### **Options**

- In determining this application the Sub-Committee may take any of the following steps 12. as it considers necessary for the promotion of the licensing objectives, namely:
  - to modify the conditions of the Licence; or
  - to reject the whole or part of the application.

For the purposes of the Licensing Act 2003 the conditions of the licence are modified if any of them are altered or omitted or a new condition added.

#### **Determination**

The Sub-committee is asked to determine the application having regard to

- (a)the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

### **Appeal**

If any party is aggrieved with the decision they can appeal to Magistrates court. The appeal period is 21 days from notification of the decision.







1. The premises shall install and maintain a comprehensive CCTV system covering the internal and external of the premises. It will also cover all entry and exit points enabling full frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open to the public and during all times when customers remain on the premises. All recordings will be kept in an unedited format for a period of not less the 28 days with time and date stamping. Recording shall be made available immediately upon lawful request of Essex Police or other Responsible Authority. Download or export of CCTV should be in the native file format with the native player.

A staff member from the premises who is conversant with the operation of the CCTV system shall be available at all times when the premises are open to the public. This staff member must be able to show Essex Police or other Responsible Authority recent data or footage with the absolute minimum of delay.

- 2. The external areas of the premises shall not be for the consumption of food or drink.
- 3. A designated smoking area will be established. After 21:00 daily the smoking area shall be restricted to 5 at any time. No drinks or glassware to be permitted in the smoking area.

I wish to register my concerns regarding this application for a new premises licence. I know that there is considerable concern about this application within the vicinity of the premises and beyond as it is perceived as being an opening up to a much wider use than that of just a restaurant.

I will contain my own comments to the licensing objective of Prevention of Public Nuisance which includes noise nuisance. I feel that the proposed sale of alcohol to 1am and late night refreshments to 1.30am could lead to clientele leaving the premises at a time and in a manner which could cause a nuisance particularly to those people living directly opposite the building. The fact that these hours are being sought for 7 days a week also seems excessive for a business which is being run as a restaurant. I would therefore ask that consideration be given to reducing the hours when licensable activities can take place.

I am also concerned that the building, as it stands at present, is not of a structure that will easily contain sound from the activities which could be taking place within it. I would ask that in granting a licence to this premises consideration be given to conditioning ways in which the sound of live and recorded music could be contained within the building and that a noise monitoring policy be put in place.

We are not against this application in principle as we have appreciated having a well-run and in-keeping restaurant on the site in the past. It would be good to see a similar business start up.

However, the application to run this as a live music venue, open to the early hours is not a sensible one and we would suggest that it should be toned down on the grounds of Public Safety, prevention of public nuisance and prevention of crime and disorder.

Public safety. The building, being the old station, is immediately adjacent to the main railway line and the level crossing. The line carries express trains to and from Stansted, as well as other traffic. There is nothing to stop people wandering on to the lines if the crossing barriers are up. When the barriers are down pedestrians have to wait to access the southbound platform as there is no pedestrian bridge. Sober people respect this but anyone whose judgment is impaired by alcohol could be tempted to jump the low barriers to catch the last train home, or just to get back into the village.

The location is also adjacent to the river. There have been drownings in the past at other establishments nearby, following late night drinking.

Public nuisance. The village does not have late night public transport. The station is unmanned and has no service information or help with taxis or other transport. We already have people knocking on doors here after falling asleep on the train and getting off confused in Roydon. Late night drinking at the venue would exacerbate this.

The noise from live music every night until 1.30 would be another nuisance.

Crime and disorder. The immediate area and the rail facilities (the waiting area, for example) are prone to vandalism and have to be repaired fairly regularly already. Drinking and this sort of behaviour go hand in hand.

As stated, we are not against a development here but it should be in keeping with other local pubs and restaurants.

I am writing to make a representation in respect to the prevention of public nuisance of the Licensing Act 2003 with regards to the licensing hours submitted by Just at Station Ltd, 185 High Street, Roydon, CM19 5EQ.

My family and I (I have two young children) live 10-15 yards from the premises and have done so for 15 years. During our time at High Street, Roydon we have experienced customers of the restaurant, under the previous occupants, leaving noisily in the early hours of the morning, smoking and drinking outside our property during the day and at night, and customers leaving bottles on our drive and by our fence. We had a good relationship with the previous occupants, however we did have to request some respect to us as a family.

We also had to request the previous occupants to turn down the recorded music after midnight and keep the doors and windows closed to reduce the level of noise and customers also sat on the porch/veranda to eat and drink well into the night especially during the summer months. If the licensing hours are to be extended until the early hours of the morning in an old property with no sound proofing or double glazing, the noise would become even more audible and therefore a public nuisance to us and other nearby residents for a longer period of time.

Whilst we understand this is a new application the hours requested are for much longer than previously and this would lead to customers leaving the restaurant later and drinking and smoking outside into the early hours of the morning. I would therefore like the committee to consider that all licensing activities between Sunday – Thursday to cease at 23.00 and at Midnight on Friday and Saturday (with the music being turned down at 11.30).

We would also like the committee to consider where on the property alcohol is drunk and served as the previous occupants allowed alcohol to be consumed within the station car park and outside our property whilst customers smoked. We would like in writing how the applicant will prevent this from happening.

I hope you understand and consider our representation and we await your response.

With regard to the above application I am the owner of High Street Roydon CM195EH which lies in the immediate vicinity of the subject premises.

Whilst I have no objection to the use of the premises as a "Mediterranean" Restaurant(the term "Mediterranean" being extremely wide as the Mediterranean laps the shores of numerous different countries with differing cultures as can be established by looking at a map in an atlas of that area) I would like bearing in mind the first paragraph to make some observations/objections which I should be glad could be taken into account in the sub-committee's deliberations as follows:-

1. With regard to the 4 grounds permitted by the 2003 Act and as set out in your undated letter, it is the case( as presumably the sub-committee is aware from the Council's records) that there are 4 licensed establishments in

Roydon Essex High Street to the "south" of the level crossing at Roydon Station,namely, The New Inn.The Crusader,The White Hart,and The Roydon House and Bar(formerly The White Horse) —the subject premises lying to the "north" of the level crossing immediately adjoining Roydon Station forecourt(being the former Franco's Italian Restaurant). In my view,given the very wide range of items set out in the Notice of Application which the Applicant seems to require,that any license which the sub-committee may be minded to grant, should be similar to and reflect those currently in force in relation to the 4 licensed premises mentioned above and perhaps reflect what was granted to Franco's now defunct restaurant save that the "end" times of each item mentioned in the Notice should be 12 midnight in each case(subject to my observations in item 4 of this email).

- 2.On the grounds of public safety and the prevention of public nuisance, Roydon High Street (both "north" and "south" of the level crossing) is a quiet residential area generally (except perhaps in the rush hours as presumably the sub-committee is aware) while Roydon itself is essentially a commuter village (serving both London and Cambridge) hence my suggestion that the "end" times in the Notice should be altered to 12 midnight in each case.
- 3 . Also on the grounds of public safety and the prevention of public nuisance, as the sub-committee is aware, smoking within the subject premises is forbidden by statute so this is likely to take place on Roydon Station forecourt(hopefully not on Platform 2) which raise the question of the applicant's clientele drinking on such forecourt(if this permitted under any licence which may be granted and if permitted by Abellio Greater Anglia or other the owner thereof). If this is the case then such area should be properly defined on a plan attached to any licence and somehow indicated to such clientele as it should be borne in mind that such forecourt fronts the main road which is the B181 under the control of Essex CC and is somewhat narrow (as can be seen by inspection) and (as mentioned above) is very busy with heavy traffic during rush hours. Use by commuters and others going to and from the Station carpark(run by NCP) over the forecourt should, I would respectfully suggest, be taken into account when considering what conditions should be included in any proposed licence. This aspect wouldn't apply, as such to any licences relating to the 4 establishments set out above.
- 4 With reference to the prevention of public nuisance, bearing in mind I do not know what was contained in any licence granted in the past when it was Franco's It.Restaurant and in view of the closeness of both 193 and 191 High Street to the subject premises, please would the sub-committee consider that should the applicant wish to have "live music" (one assumes that this includes bands), "performance of dance", "provision of facilities for dancing" and "late night refreshments", the applicant should be required as one of the conditions in any licence, to make a separate application to the licensing authority on each and every occasion with any timings to fall in line with what might have been granted to the 4 establishments set out above subject to any objections being received or the timings mentioned in item 2 above.
- 5.Provided I do not exceed the deadline imposed in your Notice of 17<sup>th</sup> November 2015,I would like(if I may) to reserve the right to put forward any further objections/observations which I might consider of assistance to the subcommittee.
- 6.I would be pleased if the sub-committee would consider the above points which I trust will be of some assistance in deciding the Applicant's application.
- 7.I shall be pleased to receive notice of any hearing which might occur in the future and of the ultimate decision by the sub-committee in this matter.

There is no public transport available in Roydon after midnight and all means of access to and departure from the village are via unlit country roads mostly without footpaths.

The establishment described is immediately adjacent to an un-gated platform on the London to Stansted Airport and Cambridge main railway line.

Anyone leaving the premises after midnight, in the dark and under the influence of alcohol would create a serious public safety risk to vehicular or train traffic and also to themselves.

Dear Sirs

Thank you for your letter of 18 November 2015, ref WK/201548144. I live in The Granary CM19 5EL. I have concerns about overspill parking from Just at the Station ending up in The Granary causing noise and disturbance in the early hours *every day of the week* as customers collect their vehicles. Parking in The Granary is already a problem, in spite of the CPZ and yellow lines. Inconsiderate, hazardous parking and waiting (for commuting passengers from the station) occurs most weekdays, and commuter collection and Just at the Station parking will certainly overlap while the geography of The Granary means on-street parking in much of the road may cause a hazard.

I also have concerns that customers could think the tow path to Roydon Mill would be a good parking spot if there was inadequate provision for free parking. There is a footpath which runs from The Granary between two houses, and where it meets the tow path at the junction with High Street has attracted long term, four wheels-up, parking this year, with subsequent risk to utilities conduited below, as well as inconvenience to pedestrians. When I contacted Essex CC they seemed to think this was not a problem; I'm not convinced the residents of The Granary, which experiences relatively frequent power cuts, share this relaxed view. There are also areas along the towpath at the rear of properties in The Granary, where there is a maintenance/service strip of land between the carriageway and the back fences, which might also prove tempting as overspill parking.

In respect of noise, I do not see that the owners, especially during the summer, would be able to contain the noise of recorded or live music within the confines of the building, and while your letter shows opening times, disbursement of Just at the Station's clientele could carry on long after its advertised closing time of 1.30 am.

Therefore, on the above bases, I formally object to any licence application received by yourselves with the timings currently shown and without adequate and comprehensive plans for free, immediately adjacent parking.

I do so in particular as yesterday I received a letter from Roydon Marina telling of their proposal to increase their number of berths by 252 and this, when taken with the advertised opening time of 11.00 am, leads to concerns about the amount of traffic the combined proposals may generate especially at summer weekends. This year I had cause to contact Epping Forest Noise Abatement after power tools were used on a longboat in conjunction with a generator for two whole days. The additional noise of traffic trying to access Roydon Marina due to inconsiderate parking by longboat owners added to the nuisance. At present no evidence has been shown that the applicants are taking any appropriate precautions to ensure noise and disturbance at all times, especially in the early hours, *including Sunday*, are minimised and confined to the immediate area. All consequences of Just at the Station's business should remain just at the station.

I have received your letter dated 18th November on the above subject.

I wish to state my objections to the proposal for the following reasons.

- 1. The premises are small, if not tiny and the floor space is inappropriate for the "Performance of Dance, Live Music, Dancing" as indicated by the licencing application, particularly if the main business is to be as a restaurant - see next point.
- 2. While the applicant is describing themselves as a "restaurant", they clearly will not do so in the event that they open. If you have restaurant tables you have no room for music and dancing. Hence they are almost certainly looking to be a bar and club with dancing which offers a modest, probably tap type finger menu.

3. The building itself is primarily wood with no double glazing or I believe cavity walls to absorb sound. Hence noise intrusion to local residents from Live Music and Recorded Music will be annoving.

- 4. Trains from Roydon Station finish just after midnight. If drinking is allowed until 01.30, seven days a week then the only way people can get home will be by taxi or car. If people are allowed by the licencing authority to drink alcohol until well after the last train has left then it could be argued you are encouraging some people to drink drive.
- 5. Developing the previous point of driving having drunk alcohol, customers will need to drive along unlit, twisting country roads from Roydon where you need all of your wits about you. Drinkers will not be able to do so.
- 6. It is inconceivable that there is a need for late night drinking, dancing and a live music venue operating into the early hours in Roydon on Sunday, Monday, Tuesday, Wednesday and Thursday evenings. A later licence on Friday and Saturday evenings might be warranted but not beyond midnight.

7. In the village we currently have four bar/restaurants which all operate successfully on normal pub licencing hours. Hence why would a new operation require longer hours - the need has not been proven.

8. If the above is pulled together - the use of the premises as a music venue is in appropriate, there is no demand for a late night venue in Roydon and the noise from the premises themselves and no doubt revellers leaving in the early morning would be an intrusion no one in Roydon would welcome or be exposed to.

Whilst the Society appreciates that the business may wish to attract customers from the later trains that stop at the village station, it is thought that recorded/live music after 11.30pm each evening maybe very disturbing for the residents opposite as well as the residents living nearby in The Granary and towards the village in the High Street. Roydon at that time of night is usually very quiet and as we know for experience noise carries. Residents know only too well that when Briggins Hotel was operating, any loud late music could be heard in the village. I see this application as similar to Briggins operating during these hours.

Local public houses respect local residents and cease music/live performances at a respectable hour. We do have concerns and these relace to extended hours for serving alcohol and a licence for him and recorded music continuing after midnight.


