Initial reports state up to one hundred people were fighting and the injuries from the incident include broken bones, serious head injuries, stab wounds and one individual with a cut throat. At one stage the local Ambulance control struggled to cope with the amount of injured

Club 195 has been directly associated with at least forty seven incidents over the last twelve months a number of which meet the criteria of serious crime and disorder. These include six incidents of Grievous Bodily Harm, ten incidents of Actual Bodily Harm, seven other Disturbances, seven thefts and six common assaults.

The most severe instances are summarised below but should be viewed only as a part of what is a serious and ongoing problem.

Severe cut to forehead ten stitches cracked/broken teeth

On the 16th of August 2009 whilst outside of Club 195 at approximately 0244 hours was punched to the floor by two suspects causing a severe cut to the fore head requiring ten stitches cracked and chipped teeth and a black eye.

D120B/09082/09 - GBH D120B/09081/09 and D120B/08659/09 - ABH 25th May 2009 0215 hours

Broken Jaw permanent pins and a severely swollen face

Both and his brother were assaulted whilst inside Club 195 on the 25 th of May 2009 at approximately 0215 hours. Was assaulted by an unknown suspect on the dance floor of the club, his jaw was broken and he now has permanent titanium pins in place. Was also punched and suffered a severely swollen face to the point where he could not be x-rayed for a number of days.
has been involved in this incident and has been punched in the face causing swelling to his right eye socket.

D120B/06614/09 - GBH 4th April 2009 0100 hours

Ear lobe bitten off

had a verbal argument with an unknown suspect whilst at Club 195 on the 4th of April 2009. Following this whilst directly outside Club 195 at 0100 hours the suspect assaulted biting his ear lobe which was ripped off, eleven stitches was required to repair the damage.

Fracture eye and jaw
Tructure eye and jaw
At 0230 hours on the 7 th of March 2009 has been pushed to the ground by an unknown suspect and has been kicked several times in the head. The aggrieved has suffered both a fractured eye socket and a fracture jaw.
<u>D120B/16440/08 - GBH</u> 20 th September 2008 0045 hours Contusion and bleeding on the brain
On the 20 th of September 2008 a weapon was used to strike September on the right side of his head resulting in a contusion on the brain and slight bleeding of the brain along with a gash to the ear and head. This occurred inside the premises of Club 195 between 0045 hours and 0130 hours.
