### **Recommendations/Decisions Required:**

(1) To consider the approach and areas of questioning at the March 2010 meeting;

(2) To consider which connected organisations should be asked to participate in the debate in addition to the West Essex PCT representative; and

## (3) To consider whether the next meeting should be held at a venue in the local affected area.

#### Report:

1. (Senior Democratic Services Officer) The Council is now in receipt of the formal consultation document on the future healthcare in the North East London. The consultation period ends on 8 March 2010. The proposals will mean changes to the location and range of services provided through the six hospitals in the North East London area. Although in London, many residents in the south of the District access these services.

2. It has been previously agreed that this Committee would look at the consultation and consider whether to make a formal response before the end of the consultation period. Arrangements have been made for the Deputy Director of the West Essex PCT to attend the meeting in March to discuss the impact of the proposals.

4. At this meeting members are asked to consider:

(i) Areas of questioning for the March meeting;

(ii) Whether they wish to invite other connected organisations to attend in March (it is suggested that a representative of the Essex County Health Overview and Scrutiny Committee be invited;

(iii) Whether arrangements should be made to hold the meeting locally to the area affected.

### Summary proposals

5. A table showing a summary of the proposals is shown as Annex 1 to this report. The consultation document should be read in conjunction as it outlines the clinical reasoning behind the changes. The main changes would appear to be removal of A & E, simple surgery and maternity Services from King George's Hospital and complex surgery (including vascular

surgery) would no longer be undertaken at Whipps Cross Hospital which will be centred on the Royal London and Queens Hospitals.

6. For background, the consultation seeks views on specific questions which are reproduced at Annex 2 to this report. It is proposed that any response be formulated at the March meeting. Officers will seek areas of questioning from members via the Bulletin in the usual way.
