A call was received on 04/01/2011 reporting a male had been seriously assaulted in the toilets of Crystal Lounge. The reason for the delay in calling was the male victim had been in hospital after sustaining a fractured leg. The informant for this call was the girlfriend of the victim as he was still in hospital. The incident stated staff at Crystal lounge may have rung the police already regarding the situation.

APS 70313 LEWIS then attended Crystal Lounge and spoke to Ross PARRY (Manager) on Wednesday 5<sup>th</sup> January 2011. He was not at the bar but holding a business meeting across the road. He didn't have keys for the bar to show me the incident book but told me the following information. The door staff found an older male in the toilets on New years eve. He appeared intoxicated. Staff were told the male was a serious diabetic and needed insulin. The male and his girlfriend asked for help getting home. A taxi was organised by the bar. Door staff asked if he was assaulted and he replied he needed to get home for his insulin. APS 70313 LEWIS was advised by the manager the incident book had been updated. The incident book was not looked at on this occasion. APS 70313 LEWIS viewed the incident book at Crystal Lounge on Thursday 6<sup>th</sup> January 2011. There was an entry detailing the above in it.
