<b>Officer Response</b> The first criterion in the para is considered to be the most important. The authenticity and integrity of the building must be fundamental to its inclusion in the Local List, as it is for the Statutory List. The suggested deletion of the first paragraph cannot therefore be supported. However it is accepted that alterations to such buildings can have been sympathetically made which would not detract from their merit . A change to the text to recognise that situation would be beneficial.
