Report

1. Introduction

- 1.3 Proposals in Appendix 2 are Council functions and are therefore subject to report to the Overview and Scrutiny Committee and the Council before they are published in the Constitution.

2.1 Appendices 1 and 2 set out the subject matter of the proposed delegation change and some notes as to why the change is thought necessary and we recommend accordingly.

3.1 We considered proposals from officers for the authority to submit planning applications on behalf of the Council to be delegated to Directors.
