Recommendation:

That funding from the Grant Aid Scheme totalling £2,500 be awarded to the King Harold Day Society.

Background:

- 1. Applications for Grant Aid funding are normally considered and determined by the Portfolio Holder for Community Wellbeing but in this instance the Portfolio Holder, being a Waltham Abbey Town Councillor, currently Mayor and, in addition an acquaintance of some of the officers working for the applicant group, has referred the application on to Cabinet, for determination.
- 2. King Harold Day Society arranges an annual event in Waltham Abbey to raise the awareness of the local heritage and history connected with Waltham Abbey. The above amount will be used to purchase some permanent interpretation boards.

Statement in Support of Recommended Action:

3. The application from King Harold Day Society for a major grant, as set out in Appendix 1, was deemed worthy under the terms of the Grant Aid Scheme in the amount stated in Column 3 and for the reasons set out in Column 4.

Other Options for Action:

4. Options considered in terms of the grant aid application were for the approval (if so the amount concerned), deferral or refusal of the application. There were no other options for consideration within the Community Wellbeing Portfolio as the only transfer of funds, which is possible, is from the various Voluntary Sector Assistant Budgets.

Consultation Undertaken:

5. Discussions with applicant group and with Officers.

Resource Implications:

Budget Provision: £92,310 set aside for long term, village hall and major grants in 2006/07. Consideration to be given to transfers between different elements at a later stage if necessary. Prior to the production of this decision sheet, the total remaining within grant aid funds was £47,840 (See Appendix 2 attached). If the application now being put forward is approved in the amount suggested this would leave £45,340 in the Grant Aid Scheme for the consideration of applications during the remainder of the 2006/07 financial year.

^{*} The three-year ruling is aimed at discouraging repeat applications from the same group relating to precisely the same approval given on a previous occasion. It states that where applicants have received a grant in the preceding years they would not be eligible to reapply within the three-year period unless the project is extremely urgent or the application relates to a separate developmental aspect of an existing scheme. The application from King Harold Day Society falls into this latter category.
