Subject: Cancellation of Article 4 Direction on O.E. 6977, Waltham Road, Bumbles Green, Nazeing

Recommendations/Decisions Required:

(1) That the progress made in respect of the cancellation of certain Article 4 directions be noted; and

(2) To note the position in respect of one particular Article 4 Direction (O.E. 6977, Waltham Road, Bumbles Green, Nazeing).

Report:

- 1. An Article 4 Direction can be served in limited circumstances, so as to restrict the normal operation of permitted development rights (that is, development that may be undertaken without the need to apply for planning permission).
- 2. To justify an Article 4 Direction there must normally have been a particular adverse impact expected from the exercise of those normal permitted development rights, perhaps because the landscape was particularly vulnerable, or the amenity impacts of certain land uses would have been unacceptable.
- 3. Following the Development Committee meeting on 18 July 1996 it was decided that the Article 4 Directions on the following properties could be cancelled:

4. These Article 4 Directions can be cancelled because the circumstances in which they were originally made were no longer considered to be relevant to the land or buildings in



question. In some cases, the criteria governing permitted development were changed, which had the effect of bringing under control certain development that may have only previously been controlled by such a Direction. The effect of these cancellations has been to return the normal permitted development rights to the properties in question.

5. The following Article 4 Directions have been retained because of their continued relevance:

- 6. The process involved in cancelling an Article 4 Direction is lengthy and has involved serving notice on the landowners and occupiers of the land or property in question. However, this work has now been completed for all but one of the Directions on the original list a site in Waltham Road, Bumbles Green, Nazeing.
- 7. After lengthy investigation, it transpired that this Article 4 Direction was never actually confirmed. It does not appear on the Local Land Charges register and there are no sealed copies in the files. Since this Direction was never confirmed, it no longer exists and revocation (cancellation) is not required.
- 8. A saving of around £550 will be made since that has been the approximate cost of revoking an order, where a newspaper advertisement has been required.
