That Grant Aid funding be awarded to Citizens Advice Epping Forest District totalling £113,840 and Voluntary Action Epping Forest totalling £39,120 via renewed Service Level Agreements for the period 1st April 2019 – 31st March 2020.

#### Reason for decision:

Both Voluntary Action Epping Forest (VAEF) and Citizens Advice Epping Forest District (CAEFD) currently receive annual Council Grant Aid funding of £39,120 and £113,840 respectively via Service Level Agreements (SLA`s). Both current 3-year SLA's expire on 31<sup>st</sup> March 2019. Objectives and delivery targets are discussed and agreed with both organisations annually. Quarterly monitoring is undertaken to ensure key agreed objectives are delivered.

Initialled as original copy by Portfolio Holder:

The needs of the district's residents are central to the award of Council Grant Aid funding. There is an aspiration to continue to support both VAEF and CAEFD for a further period, however, to ensure best value, it is recognised that enhanced, robust monitoring mechanisms will need to be implemented moving forwards.

A shared performance dashboard encompassing the joint funding objectives of both EFDC and ECC was agreed with VAEF and piloted throughout the period April 2018 – March 2019. This new performance management framework has proved an effective and efficient tool in which to monitor the grant funding awarded by both organisations to VAEF. A full review of the shared dashboard will be undertaken throughout the coming year to ensure the success of future co-commissioning arrangements.

#### **VAEF**

VAEF is currently commissioned by EFDC to deliver shared objectives with ECC around community development, social isolation, depression screening, Mental Health First Aid interventions, fall prevention, obesity and warmer homes initiatives.

In addition to EFDC Grant Aid funding of £39,120, VAEF receives £40,000 towards the Gardening Service and £36,000 for the Handy Man Service from the Housing directorate.

### **CAEFD**

CAEFD is currently commissioned by EFDC to deliver a range of objectives including; outreach services in Ongar and at Norway House in North Weald, financial advice for young people and referrals to external organisations via the Frontline social prescribing website. In addition to EFDC Grant Aid funding of £113,840, CAEFD receives £42,000 to deliver the Limes Farm Debt Mitigation Service from the housing directorate.

### Options considered and rejected:

- Not to fund VAEF and CAEFD and issue Grant Aid Service Level Agreements. This was rejected as the Council recognises the services and support both organisations provide to local residents. This would cause major financial concerns for CAEFD which is very reliant on Council funding. Approximately 70% of income receipts to CAEFD is from Epping Forest District Council.
- 2) Re-issue 3-year SLA's to both organisations. This was rejected as the Council is committed to reviewing, agreeing and implementing further improvements to the performance management frameworks for both grants over the coming year.
- 3) Release a percentage of funding at the start of the year and then release further funding on a performance by results basis. This was rejected as this is a very different way of funding organisations and would require detailed research and lengthy negotiations prior to implementation. Whilst this may be considered as part of the coming review, it would not be achievable by 1st April 2019.
- 4) Any of the above, with a reduction of funding (no reduction 2019-20, followed by incremental reduction to ensure organisations can plan appropriately for decrease in funding levels). This was rejected as the Council and Members are committed to supporting local groups and funding such groups meets Corporate objectives in terms of Stronger Communities.
