# PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980 – SECTION 119 ESSEX COUNTY COUNCIL FOOTPATH 33 EPPING


This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owners of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

#### BY THIS ORDER:

- 1) The public right of way over the land situated south of Albany Court known as Footpath 33 Epping in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-19-15 rev.20.06.19 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Albany Court known as Footpath 33 Epping in the District of Epping Forest described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-19-15 rev.20.06.19 contained in this order.



#### **SCHEDULE**

#### (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 33 Epping of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 54578,20235 located at the pathway running behind the properties of Albany Court running in a north westerly direction through property boundaries for a total distance of approximately 54 metres to point **B** at grid reference 54576,20240 where it connects to the public highway known as Albany Court.

## (PART 2)

## DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being of variable width being boundary to boundary shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a north easterly direction along an existing pathway for a total distance of approximately 31 metres to point **C** at grid reference 54580,20237 where it connects to the public highway known as Albany Court being 54 metres south east of its existing connection to that highway.
